## Noticed Meeting on Duval County 2025 List of Priority January 28, 2024 Minutes

Transportation Planning Organization (TPO) Executive Director Jeff Sheffield presented 01282025 Handout 2 Noticed Meeting CM Peluso RE Duval County 2025 List of Priority Projects which proposed a revision to the TPO List of Priority Projects process to increase the number of projects to 25 (a 5 project increase). Council Members expressed support for the revision. Mr. Sheffield confirmed it would be in their board packets at the next TPO Board of Director's meeting.

Council Member Peluso directed the attendees to the Handout 1, the draft Duval County 2025 List of Priority Projects. City Manager of Atlantic Beach Bill Killingsworth confirmed the projects that he was watching, one for a roundabout, were on the list. Staff confirmed they were. Council Member Peluso motioned to correct the boundaries for Priority Item 9 Beaver Street (SR 10) to be McDuff and Liberty Street; Council Member Pittman seconded; all in favor. Council Member Pittman confirmed her projects were on the list; Chief Santana agreed. With no further Council Member concerns, Council Member Peluso moved the draft Duval County 2025 List of Priority Projects as amended; Council Member Pittman seconded; all in favor.
