### **Noticed Meeting Council Member Jimmy Peluso Landlord Registry Next Steps January 28, 2026 Minutes**

**Location:** Lynwood Roberts Room, City Hall at St. James, 117 West Duval Street, Jacksonville, Fl, 32202

**Discussion:**

The results showed there is room to create local protections for renters to ensure safe housing conditions. The project would be called the "Rental Registry" moving forward.

Researcher Katie Renzi presented on the Rental Housing Market Conditions in Duval County. She shared that 58.7% of renters are cost-burdened, spending more than 30% of their income on rent and that Duval County had become the Eviction Capital of Florida with 82 evictions were filed for every 1,000 renter households, more than any other county. Attorney Suzanne Garrow noted that evictions, even if only filed, remain on a tenants record forever. Other important points included: only five owners accounted for 20% of all eviction filings in the county, just one owner accounted for 23% of all building code violations, 31% of code compliance visits were to properties owned by two owners, Local "mom and pop" landlords were the least likely to file evictions or have code violations.

Attorney Garrow presented on the intersection of rental housing and the civil justice system in Jacksonville. She showed a map of the 2021-2022 evictions. The group discussed the importance of transparency to allow neighbor who are looking to rent to make informed choices about their housing. Code Enforcement Chief Christopher Billings noted the difficulty in finding owners when tenants were in crisis, for example if the roof caved-in.

Council Member Peluso and the group discussed the core pillars of the proposed resources and Rental Registry, including:

- I. An Ombudsman Office to facilitate resources and serve as case manager.
  1. The Mayor's Administration committed to developing the position inside the neighborhoods department.
- II. State of Housing Report to inform policy makers of the issues and to track progress.
  1. Affordable Housing Manager Joshua Hicks discussed the data that would be useful to track and to aggregate into a report. Council Member detailed his intent to codify the report, similar to the State of the River Report conducted annually by Jacksonville University.
- III. Rental Registry
  1. Jacksonville Area Legal Aid Rental Registry committed to creating and running a rental registry that could be used by renters to find safe housing using a search feature. Chief Chris Billings said he would work with the Office of General Counsel to ensure the ability to share real time data with JALA.

Twelve people gave Public Comments. Many comments were in support of the Rental Registry and shared personal testimony to why such resources would be important. Council Member Peluso answered questions.
