### **Noticed Meeting CM Peluso RE 2026 List of Priority Projects January 29, 2026 Meeting Minutes**

**Location:** Lynwood Room, City Hall at St. James, 117 West Duval Street, Jacksonville, FL 32202

**Attendance:** Council Member Jimmy Peluso, Council Member Randy White, Public Works Director Nina Sickler, Chief Lurise Bannister, Sr. Coordinator Matt Fall, Director of Planning and Development Helena Parola, Florida Department of Transportation Urban Transportation Development Manager Jim Knight, Attorney Terrence Harvey, Inter-Governmental Affairs Director Brittany Norris, Executive Council Assistant Brooks Dame. **Meeting Convened:** 4:03 p.m.

**Discussion:** Council Member Jimmy Peluso thanked everyone in attendance. Everyone introduced themselves. Director of Public Works, Nina Sickler, presented the draft list of priority projects, noting the pink projects were funded previously and that the top 10 projects under that would be prioritized. Chief Lurise Bannister shared the list was developed based on safety, funding available, readiness, prior commitments, and combining inputs from various departments and council members.

Council Member Randy White mentioned a minor spelling error and incorrect fire station listed; staff confirmed this would be corrected. He asked about a project in his district. Florida Department of Transportation Urban Transportation Development Manager Jim Knight responded that the four county region (Duval, Nassau, St. Johns, and Clay) receive 20 million to advance projects each year, and that this specific project would cost hundreds of millions. He did note the Project Design and Engineering for certain parts of Normandy would happen this calendar year. Additional segments required in later years.

**Public Comment:** Mr. John Nooney spoke passionately in support of river access and Florida Inland Navigational District projects.

**Action Item:** Council Member Peluso motion to move the draft list, as presented with minor corrections discussed, to file as a resolution for Duval's List of Priority Projects. Council Member White seconded. All in favor; none opposed.
