- 11. 4.02 Allocation of Powers between branches- "In the event the nature of any power or duty is uncertain, or the law creating such power or duty requires a combination of branches of the consolidated government, the president of the Council, the Mayor, and the presiding judge of the circuit court shall affix responsibility to the exercise of such power or performance of such duty."
- 12. Council has ability to amend Charter, but some amendments must receive approval in referendum before they become effective
- 13. What is boundary of 1<sup>st</sup> urban service District? Obligation to provide services (such as streets and drainage) within urban service district but not rural areas
