• Concession Buyout Fee

• Labor Requirements

Park Staff – City of Jacksonville employees will provide labor, to include electricians, at the prevailing rate of the positions required to work the event. The scope of the event and projected attendance determines the number of City staff required.

Public Safety – Jacksonville Sheriff's Officers and Jacksonville Fire Rescue Medics will be present at all events. The number will be determined by that department based on the scope of the event and projected attendance. Contact the Metropolitan Park Event Coordinator for current rates.

Dear Rick:


Pursuant to our conversation this date, please find attached Ordinance 82-1064-485, which includes the agreements with WJCT, Inc; Resolution 84-1179-450, noting Rate Schedule, Service Changes, and Lease Agreement; and Ordinance 84-1087-687, which creates a Metropolitan Park Maintenance and Improvements Fund.

In regards to admission events at Metropolitan Park, it is my understanding that your agency agreed that a total not to exceed twelve (12) paid events per year could be held at the facility. Further, that six (6) of the events would be produced by WJCT Channel 7, of which the revenue would be retained by WJCT, and six (6) events produced at the discretion of the City, as long as the revenues generated were committed to the development, operation and maintenance of facilities at Metropolitan Park.

In an effort to clarify any misunderstanding now and in the future, I am requesting that your office review the files concerning Metropolitan Park, and provide me with a written opinion concerning this matter.

Please advise if additional information is needed.
