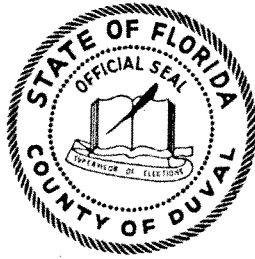

Re: Diversity Amongst Duval County Canvassing Board Members

Dear Chief Judge Moran and City Council President Gulliford:

I write as the chair of Jacksonville's Election Advisory Panel ("EAP"), which is tasked with helping better voter registration and elections in Jacksonville. A topic that arose at our January, 2013 EAP meeting after this past election is the frequency that there has been a lack of diversity with the members comprising the Duval County Canvassing Board – often comprised of only ~~white Republican men~~.

The EAP contacted the Supervisor of Elections of the 6 counties with greater voter registration totals than Duval and all demonstrated that their Canvassing Boards have a history of diversity.

The EAP believes that Jacksonville elections and public confidence and perception about the election process would best be served by having a Canvassing Board that is diverse (sex, race, age, political party). As such, we request that you make this a consideration in structuring how a Canvassing Board member is selected and, if applicable, who as a replacement is selected to be a Canvassing Board member, pursuant to §102.141, F.S.
