Homestead, FL

Permit required

Restricted to non-profit organizations only

Buffer requirement (landscaping, walls or similar screening)

Limit of 1 donation drop box on a single parcel of land

Each non-profit may have only 1 permit

Hurricane removal

Unlawful notice

Miami-Dade County, FL

Donation bins restricted to property owned and operated by a non-profit organization

Located at least 75' from any property line

Plant City, FL

No more than 1 donation bin on site 5 acres or less

No more than 2 donation bins on sites more than 5 acres, with minimum 1000' foot separation

Donation bins must be placed at least 50 yards from any store that sells over 25 gallons of
fuel/flammable liquids

Donation bins shall be permanently affixed to the ground

Donation bins shall not have a floor area greater than 20 sq ft or a height exceeding 6'

Deerfield Beach, FL

Donation bins other than for clothing are prohibited

Allowed on property of a retail or professional building with at least 30,000 sq ft of interior space

Allowed on property of a shopping center of at least 100,000 sq ft of building size

Orlando, FL

Prohibited on undeveloped or unoccupied property

Required safety chute to prevent vandalism

Donation bins must be no further than 12" apart

\$275 permit fee

Miami, FL

Donation bins prohibited

Broward County, FL

Donation bins shall have wheels affixed to bottom and be readily moveable

Florida City, FL
