4 **ORDINANCE 2017-501**

5 AN ORDINANCE LEVYING ANNUAL TAXES FOR THE 2017
6 CALENDAR YEAR ON REAL AND PERSONAL PROPERTY
7 LOCATED IN THE GENERAL SERVICES DISTRICT OF
8 THE CITY OF JACKSONVILLE, NOT INCLUDING THE
9 SECOND, THIRD, FOURTH AND FIFTH URBAN SERVICES
10 DISTRICTS (THE CITIES OF ATLANTIC BEACH,
11 NEPTUNE BEACH, JACKSONVILLE BEACH AND THE TOWN
12 OF BALDWIN); STATING THE PERCENTAGE INCREASE
13 FROM THE 2017 ROLLED-BACK RATE; AUTHORIZING
14 ASSESSMENT AND COLLECTION; PROVIDING FOR THE
15 USE OF THE REVENUES GENERATED; PROVIDING AN
16 EFFECTIVE DATE.

18 **BE IT ORDAINED** by the Council of the City of Jacksonville:

19 **Section 1. Ad valorem tax levy - General Services**
20 **District, excepting Urban Service Districts 2 through 5 (The**
21 **Beaches and the Town of Baldwin).** In accordance with Chapter 200,
22 Florida Statutes, for the year 2017, there are hereby levied upon
23 all taxable property located within the General Services District
24 of the city, excepting the Second, Third, Fourth and Fifth Urban
25 Services Districts, for county, district and municipal purposes, ad
26 valorem taxes expressed in terms of mills on each dollar of
27 assessed taxable valuation in the amount of 11.4419 mills, or
28 \$11.4419 per \$1,000 assessed taxable value.

29 **Section 2. Percentage increase from the rolled-back rate.**
30 The 2017 operating millage rate levied herein by the Consolidated
31 City of Jacksonville upon property within the General Services

1 District of the city, excepting the Second, Third, Fourth and Fifth
2 Urban Services Districts, represents a 10.32% increase from the
3 2017 rolled-back rate set forth in Resolution 2017-500-A.

4 **Section 3. Assessment and collection.** The Property
5 Appraiser of the county is authorized and directed to assess, and
6 the Tax Collector of the County is authorized and directed to
7 collect, pursuant to law, the ad valorem taxes levied in this
8 ordinance.

9 **Section 4. Use of revenues.** The revenues raised by the
10 ad valorem taxes levied in this ordinance shall be utilized in the
11 manner and for the purposes specified in the 2017-2018 budget and
12 appropriations ordinance.

13 **Section 5. Effective Date.** This ordinance shall become
14 effective upon signature by the Council President.
