Potential Solid Waste Construction Debris Surcharge Collected at Issuance of Building and Roofing Permits


- OGC does not see an issue of a solid waste construction debris surcharge being collected at the time of issuance of a building or roofing permit.
- Almost all building and roofing permits would be expected to generate some amount of waste. Some Converting Use permits, Move On Building permits or Mobile Home permits may not generate waste. These types of permits represented only 40 out of 14,664 permits issued between Nov. 16, 2016 to Nov. 17, 2017 (0.27%). Because the overwhelming majority of building and roofing permits generate waste and those that may not represent an insignificant amount, all building and roofing permit types should be included in this proposed surcharge.
- Many current permit fees are determined based on the square footage of a structure or the
 value of the project; therefore, the larger the structure, the higher the fee. Typically, buildings
 of larger square footages would be expected to generate more waste (i.e. a building permit for a
 shed would generate less waste than building permit for an Amazon Distribution Center). As
 such, it would appear to be more practical to charge a solid waste construction debris surcharge
 on a percentage basis of the building permit fee.
- Between 2014 and 2017, an average of 27,278 permits was issued annually. For the years 2014 and 2015 (non-hurricane years), the average number of permits issued was 24,409.
- Between 2014 and 2017, the Building Inspection Division average annual revenue collection for building and roofing permits was \$5,522,676. For the years 2014 and 2015 (non-hurricane years), the average revenue collected was 5,480,228.
- Based on an average of 25,000 annual building and roofing permits, a per permit surcharge of between \$20 and \$24 would generate between \$500,000 and \$600,000. A per permit surcharge
 of \$112, would generate revenue of \$2.8 million.
- Based on annual revenue to the Building Inspection Division from building and roofing fees of \$5.5 million dollars, a permit surcharge percentage of 9.1% to 11% would generate between \$500,000 and \$600,000. A permit surcharge percentage of 51% would generate \$2.8 million.

Should the Special Committee on Solid Waste decide to pursue this option, our recommendation would be for a Solid Waste Construction Debris Surcharge of 10% of the Building Inspection Division Fees for Building and Roofing permits.



ORDINANCE 2015-692-E

AN ORDINANCE AMENDING SECTION 380.405 (HOST FEE; DISTRIBUTION FORMULA; LATE CHARGE FOR DELINQUENT PAYMENT), CHAPTER 380 (SOLID WASTE MANAGEMENT), ORDINANCE CODE, TO ADD A NEW SUBSECTION (F), TO ALLOW A SOLID WASTE C & D DISPOSAL FACILITY, WHICH RECYCLES MATERIAL AND DISPOSED OF RESIDUAL MATERIALS OUT OF THE COUNTY, TO RECEIVE CREDIT FOR THE HOST FEES; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the host fee upon collection is divided into three sub programs: contamination assessment and remediation programs at closed landfills; landfill closure; and landfill mitigation which benefits the surrounding properties in the neighborhood of the landfills; and

WHEREAS, the ordinance code change will allow those that take residual waste out of county and therefore would not contribute to any of those problems within Duval County; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Amending Section 380.405 (Host Fee; distribution formula; late charge for delinquent payment), Chapter 380 (Solid Waste Management), Ordinance Code, to add a new subsection (f). Section 380.405 (Host Fee; distribution formula; late charge for delinquent payment), Chapter 380 (Solid Waste Management), Ordinance Code, is hereby amended to add a new subsection (f) to read as follows:
