Definitions for treatment services listed above:

Assessment: The Clinical Assessment process consists of an initial screening and if needed comprehensive assessment to determine eligibility for Substance Abuse Treatment and/or Mental Health Treatment within the Program. The severity of a Participant's assessment determines if the Participant is placed in Residential, Outpatient, Mental Health or Co-occurring treatment services.

Outpatient Services: Outpatient Treatment Services consist of individual and group treatment sessions following the phase requirements for the Program or will be individualized to assist the Participant in successful completion of treatment. This includes a minimum of one (1) Individual Session each month for each Participant.

Residential Treatment: Residential Treatment Services include residing in a highly structured, live-in environment utilizing a planned regimen of services through an interdisciplinary team approach. Participants receive over 40 hours of intensive treatment each week, consisting of one- on- one counseling, group therapy sessions, education and other treatment modalities as needed. Referrals are made based on a comprehensive assessment performed by a substance abuse professional. This also includes co-occurring mental health services and medication management for Participants as needed.

Mental Health Services: Licensed Mental Health Professionals will provide Comprehensive In-Depth Assessments or Psychiatric Evaluations on an as needed basis.

# Adult Drug Court COJ Funds Budget: October 1, 2018- September 30, 2019 Requested Funding: \$329,500.00 Budget Provides Case Management, Drug Testing, and Treatment Services For 125 Participants

Depending on the outcome of the evaluation, services will be provided including mental health counseling, medication recommendations and ongoing medication management.

Drug & Alcohol Testing: The Program will conduct random, observed, urine drug and alcohol testing at a minimum of two times per week. Additional monitoring as needed by utilizing an ankle monitor designed to monitor the Participant for ingestion of alcohol twenty-four (24) hours per day may be utilized as will the use of a drug testing patch when necessary.

Case Management: Case Managers provide one-on-one case management to all Participants and will provide routine updates on progress/lack thereof to the court. Case Managers liaise with treatment providers and all community partners to ensure necessary services are being provided. Case Managers attend all staffing meetings and court sessions and provide written reports on participant progress. Case Managers conduct, at minimum, bi-weekly visits with program participants. Case Managers assist with obtaining and maintaining services such as medical appointments, obtaining or reinstating disability benefits, housing, referrals for vocational training, educational programs, and employment opportunities, and other needs. Case Managers collaborate with stakeholders to identify areas of need to develop lines of communication, continuity of care, and effectiveness. Case Managers maintain participant records and prepare detailed court calendars and pre-court staffing agendas that are disseminated to ADC team members.
