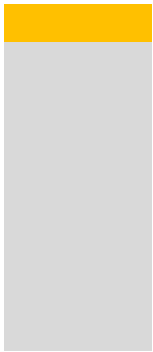

SUBJECT: 2019-20 Jacksonville Waterways Commission

Per your request, below is a summary of the Jacksonville Waterways Commission activities for the 2019-20 year for the reporting period of July 1, 2019 through June 30, 2020.

Summary of Commission Prior-Year Activities

The following subcommittees have continued to meet and report back to the Jacksonville Waterways Commission:

1) Derelict Vessels and Floating Structures Committee

- Task Force Members: Lindsey Brock - Chair, Mark Devereaux, Garret N. Barket, Mark Hardesty, Robert Birtalan, Marshall Adkison (Ex-Officio)

2) Florida Inland Navigation District (FIND) Subcommittee

- Subcommittee Members: Jill Haskell-Chair, Raymond S. Pringle, Jr., Matt Brockelman, Marshall Adkison (Ex-Officio), Lindsey Brock

3) Due to COVID-19, there have been two meetings cancelled in 2020, April and May, and one meeting rescheduled in June.

The Chair of Jacksonville Waterways Commission Council Member Al Ferraro asked for volunteers from the Waterways Commission Members and interested citizens for the subcommittees. They have been tasked with getting information regarding the 2018-19 subcommittees' recommendations and reporting back to the Waterways Commission with their progress.

Council Member Ferraro asked for volunteers to report back their findings throughout the year on the Water Activation Focus Areas. The most updated Water Activation Focus Areas List was sent to all members of the Waterways Commission for the members preferred assignments. Commissioner Jill Haskell spoke on the topic of the Task Assignment: "Cultivate a Culture that proclaims the Great Attributes of our Rivers & Ocean." The Commission voted on the recommendation to draft a resolution to designate a "Boater Skip Day." The motion passed and the Boater Skip Day had a massive turn out in June 2020.

In August 2019, the proposed Jacksonville University "Manatee Protection Project" Continuation that was Approved. In December 2019, the Manatee Implementation Report was presented.

Commissioner Ray Pringle gave periodic updates throughout the year on the status of new Adaptive Kayak Launches throughout the City.

In November and December 2019, Brian Burket, Daryl Joseph, and Robert Skalitzky reported to the FIND Subcommittee what the Parks Department planned for Jacksonville Docks and Parks in 2020. These Commissioners volunteered as FIND members: Jill Haskell-Chair, Raymond S. Pringle, Jr., Matt Brockelman, Marshall Adkison (Ex-Officio), and Lindsey Brock. The FIND Subcommittee held a meeting on December 4, 2019, to discuss upcoming projects for 2020 and the upcoming years. There are several projects in the City that are in progress. Additionally, in June 2020, Mark Crosley from FIND provided a presentation at the full Waterways Commission of the Dredge Spoil Site Schedule, an update on sites throughout the City, the issue of illegal access on sites, and the problem of illegal dumping of materials.

Robert Skalitzky and Council Member Ferraro provided updates on the Shad Creek Speed Zone signs. Signage was added to Shad Creek for an additional no wake zone.

Commissioners Lindsey Brock, Mark Devereaux, Garret N. Barket, Mark Hardesty, Robert Birtalan, Marshall Adkison, and staff member Susan Grandin held meetings for the Derelict Vessels and Floating Structures Committee regarding drafting of legislation. They met on November 6, 2019, January 29, 2020, March 6, 2020, and June 22, 2020. There were several Derelict Vessels removed from the Ortega River in coordination with JSO, Captain Jim Suber, and other entities. Discussion on the Anchoring of Vessels in Anchoring Limitation Areas (House Bill 417 and Senate Bill 606) was addressed in the Committee and presented to the Commission as well. Susan Grandin and the JSO Marine Unit provided an overview of issues at Private Marinas which was included into the Derelict Vessels and Floating Structures Committee.

Commissioner Mark Devereaux discussed the creation of an "American Heritage River Funding" Subcommittee, which had not been created.

On February 12, 2020, Brian Burket provided a summary of recently completed waterways projects including, the Half Moon Island Preserve and Boat Ramp, Palms Island Fish Camp, County Dock Pier, and two Adaptive Kayak Launches. An additional presentation was presented from the Parks Department in June on the City Docks and Ramps.

In March 2020, Jason Harrah from the U.S. Army Corps of Engineers provided a presentation on the Ft. George Inlet that detailed the history of the erosion and possible solutions to the erosion. In June 2020, Jason Harrah provided an updated feasibility study on the Ft. George Inlet.

On June 17, 2020, the Waterways Commission held the first Virtual Meeting. Jim Suber presented on the King Fish Tournament scheduled in July.

The Jacksonville Waterways Commission meets on the second Wednesday of the month. There have been two meetings cancelled in 2020, due to Coronavirus concerns in April and May. One meeting was rescheduled for June. The current positions are filled. There were four vacancies in this past annual reporting year; all have been filled. The Commission is charged to formulate an overall plan for dealing with any problems that exist in the St. Johns River and Duval County tidal waters and to devise methods of developing future uses of those waterways.

The Commission serves as the Duval County committee to review rules proposed by the Florida Fish and Wildlife Conservation Commission governing speed and operation of motorboats to protect manatees. The Jacksonville Waterways Commission acts as a coordinating agency and specialized advisor for governmental units and for programs and activities affecting the improvement, development and protection of the St. Johns River and all tidal waters in Duval County. In the course of its work, the Commission conducts research, collects and analyzes data and prepares maps and charts.
