DEADLINES: Form 9 gift disclosure due March 31, 2019

Dear Council Member,

As you know, you are required to file financial disclosure with the State Ethics Commission every July, and therefore, you are also required to file **quarterly gift disclosures**. You only file a gift disclosure form **if** you received any gifts over \$100 for the previous quarter. This could be a gift from the City, such as 2 tickets to an event worth in excess of \$100. (example: football tickets)
The Form 9 for reporting is attached.

Gifts received in the October-December 2018 quarter are due by the end of this month (March 31, 2019). If you received any gifts (football tickets, travel, etc.) for this time period, you need to file your "Form 9" gift disclosure with the State Ethics Commission in Tallahassee.

If you did not receive any gifts over \$100, you do not have to fill out the form.
