The Task Force report is due on 5/1/19. It is not clear if this is to be a preliminary or a final report. While our subcommittee work may continue, we agreed that we should, at a minimum, work

toward submitting an inventory, have a good outline, and be prepared to provide direction to the Task Force by 4/26/19.

With this short deadline in mind, we plan to focus our efforts over the next few weeks on the five elements identified in the above mission statement. We expect each Subcommittee member to scan literature or to make contacts in either the public or private sector, using the attached interview guide where appropriate, and to report back to the Subcommittee by 3/28/19.
