Many have difficulties finding jobs which often causes them to get into trouble again. Our program provides supportive services and national recognized training, certifications and credentials.

Our *ISTP* team has over 50 years combined experience in recruitment, training and placement. Our job is to assist our young troubled adults towards career pathways. Past trainees have gone on to become valuable tax paying citizens.


Our team believes that the best anti-crime solution is increased education and employment. The need for trained employees has increased in Jacksonville, Florida. The *ISTP* program will implement a multi-faceted plan to effectively market the program to prospective students and recruit in Duval County Designated Qualified Opportunity Zones. These area have been selected due to the high impact of crime in those communities.

When we look on the influence of work on criminal behavior. It stems from a basic perspective that work, at both the individual and community level, can shape attitudes, influence behavior and structure lifestyles. We believe our *ISTP* program can train and introduction young adults to the industrial industry, new labor market opportunities, and employment experiences, at both the macro and micro levels. This will play an important role towards reducing crime in Duval counties most impacted neighborhoods and communities. Comprehensive strategies will be utilized to screen residents, and to identify and select participants. These trainees will receive nationally recognized credentials and certifications. Duval County is currently in need of a "*NO COST*" industrial training programs for its disadvantaged, under employed and unemployed young adults between the ages of 16 to 24. The purpose of this programs will be to mitigate these problems with training geared towards sustainable employment in Jacksonville's workforce.
