2018-19 Jacksonville Waterways Commission

Per your request, below is a summary of the Jacksonville Waterways Commission activities for the 2018-19 year for the reporting period of July 1, 2018 through June 30, 2019.

Summary of Commission Prior Year Activities

The following subcommittees have continued to meet and report back to the Jacksonville Waterways Commission:

1) Downtown River and Waterfront Activation Task Force

The Chair of Jacksonville Waterways Commission, Council Member Lori Boyer tasked for volunteers from the Waterways Commission Members and interested citizens. They have been tasked with getting information regarding prior years 2017-18 subcommittees' recommendations and report back to the Waterways Commission with their progress.

According to Council Member Boyer in the 2019 May Waterways Meeting, discussion in Waterways last year regarding water quality impacts and loss of wetlands led to a deeper examination of a whole range of issues regarding development approvals, the filling of wetlands, and what authority the City had. In the 2018 August Waterways Meeting, a resolution was adopted encouraging the Council President to appoint a task force or a subcommittee to look at those issues and see how both our stormwater infrastructure and our resiliency to flood events could be enhanced. Thus, the Council President and Administration together created the Storm Resiliency and Infrastructure Development Review Committee, chaired by Mr. Sam Mousa, and included participants of many of the regulatory agencies, such as the US Army Corps of Engineers, FEMA, the DEP, and the Water Management District. Council Member Love, John Pappas (Public Works Department), and JEA are also members that serve on the Committee.

On June 12, 2019, Bill Killingsworth presented before the Waterways Commission a Stormwater Resiliency Report preceding Sam Mousa's formal presentation at the June 25, 2019 City Council Meeting. He discussed outcomes from the Storm Resiliency & Infrastructure Committee Meeting including changes to 652 adopted at the recent meeting, a bill adopted but that had not made it to committee yet and that added changes to 654 &

656, and the reestablishment of an inner agency working/coordination group that is composed of the Water Management District, DEP, and the City of Jacksonville which will all take part in cross-training of systems. Mr. Killingsworth also discussed long-term strategies that were in the works, in addition to reporting the Committee's recent recommendation of a 25-foot average buffer with a minimum of 15-foot buffer around the wetland, consistent with what is already in the Comp Plan but that will require the buffer at all times. Mousa's formal presentation at City Council on June 25, 2019 will include a discussion regarding the intent of the Storm Resiliency & Infrastructure Committee, the challenges that were identified both for new and existing developments, and the responses of the ommittee.

Ex-Officio Marshall Adkison, Commissioner Matt Brockelman, and Executive Director of TISIRI Corp. Joe Kistel held two meetings on Reef Restoration to find available locations for artificial reefs and to create additional reefs within the 3-mile radius. In March's meeting, Mr. Sam Mousa agreed to present a recommendation to the Mayor for the inclusion of a "Reef Coordinator" position in the 2019-2020 Budget. This contract position will entail monitoring/extending reef permits and locating/monitoring reefs. The appropriate candidate will be a consultant on an as-needed basis.

Commissioner Steve Davis and Council Member Lori Member held one meeting to discuss awareness of Sailing Events on the St. Johns River. Council Member Boyer requested that James Croft, Senior Public Affairs Officer, Executive Office of the Mayor, have his office engage the Special Events staff in a discussion on how the City could best support sailing events and activities in the area, in collaboration with the many different sailing groups in Jacksonville.

Commissioner Raymond R. Pringle, Jr. and Council Member Lori Boyer held one meeting on Kayak Launches and Adaptive Sports. Commissioner Pringle reported at the April Waterways Meeting that a Kayak Launch will be delivered to Hanna Park.

Commissioner Jed Davis held one meeting on Downtown River and Waterfront Activation Taskforce to assess and make recommendations on downtown loading and unloading docks.

Commissioner Jill D. Haskell and Council Member Al Ferraro held one meeting on Waterways Special Events to raise and discuss ideas for possible future special events that can be done on the river, particularly boating activities.

Council President Aaron Bowman and Council Member Lori Boyer held one public meeting to learn more about the proposed Jacksonville Waterways Commission's (JWC) resolution supporting the creation of a City Council special committee addressing drainage and flooding issues.

Additionally, the Jacksonville Waterways Commission voted 8-0 at the June Waterways Meeting to support the drafting of legislation regarding Shad Creek Eligible Speed Zones (F.S. 327.46).

The Jacksonville Waterways Commission meets every second Wednesday of the month. The current positions are filled and there have been no vacancies in this past annual reporting year. The Commission is charged to formulate an overall plan for dealing with any problems that exist in the St. Johns River and Duval County tidal waters and devise methods of developing future uses of those waterways.

The Commission serves as the Duval County committee to review rules proposed by the Florida Fish and Wildlife Conservation Commission governing speed and operation of motorboats to protect manatees. The Jacksonville Waterways Commission acts as a coordinating agency and specialized advisor for governmental units and for programs and activities affecting the improvement, development and protection of the St. Johns River and all tidal waters in Duval County. In the course of its work, the Commission conducts research, collects and analyzes data and prepares maps and charts.
