



J-1 Bill & Relevant Legislation

What is it?

- J-1 is an act to amend Florida Law to provide for appointment of members of the Duval school board
- Proposed substitute for J-1 seeks to amend Florida Law to provide for election f the superintendent of schools for a four year term with a two term limit.

2019-0711 Resolution (In Rules Committee) 9/24/2019 Expressing Council's Opposition for Proposed Substitute to Local Bill J-1 to be Considered by Duval County Legislative Delegation, which would place a Referendum Question on the Ballot to Amend Chapt 92-341, Laws of FL, and Sec 13.07, Charter of City of Jax, to provide for elected rather than appointed Superintendent of Schools, to provide for a term of four years, to provide for a two-term limit, and to provide for Holdover the Current Superintendent; Encouraging Duval Delegation, if J-1 as substituted is supported by the Duval Delegation, to make an Amendment to J-1 to elect the Chief E








Edgewood Road Diet Edgewood from US 17 to Post St

Future Capital Improvement & District Projects 2022-2024

- Apache Avenue Curb & Gutter
 - Proposed Funding FY 22-23 = \$75,000
 - Proposed Funding FY 23-24 = \$300,000
- Dancy Street Curb & Gutter
 - Proposed Funding FY 22-23 = \$75,000
 - Proposed Funding FY 23-24 = \$235,000
- Riverside Park Duckpond
 - Proposed Funding FY 22-23 = \$1,000,000
 - Proposed Funding FY 23-24 = \$1,000,000

- Edgewood Ave. Road Diet Project
 - In process now
 - Will add parking and vehicle / pedestrian safety
 - May include artistic lighting display under US-17 overpass
 - Joint project COJ / FDOT
 - Cost / funding not presently known
 - Murray Hill Playground
 - Proposed Funding FY 22-23 = \$225,000.00

DIA Parking Proposition

- DIA has been presented with a proposition from a company, Elite Parking Services of America, proposing a 30-year contract to manage parking in downtown, including the authority to set the rates for parking meters and cityowned garages.
 - Smartphone apps could notify parkers when their meter time is about to end and let them extend the time by using the app.
- In addition to downtown, Elite proposes the contract cover parking management for areas of Riverside, San Marco Boulevard and San Marco Place where congestion can make it hard to find a parking spot at busy times.
- If the DIA board decides to consider privatizing parking, the next step would be to put out a solicitation for all entities interested in making offers.
- City Council ultimately would have the final word if the DIA board supported a long-term management contract.
