AN ORDINANCE APPROPRIATING GRANT FUNDS IN THE AMOUNT OF \$1,500,000.00 FROM THE ST. JOHNS RIVER WATER MANAGEMENT DISTRICT FOR ITS PARTICIPATION IN THE COSTS OF THE MCCOY'S CREEK IMPROVEMENT PROJECT, AS INITIATED BY B.T. 19-128; AMENDING THE 2020-2024 FIVE-YEAR IMPROVEMENT PROGRAM CAPITAL APPROVED BY ORDINANCE 2019-505-E TO PROVIDE FUNDING FOR "MCCOY'S THE PROJECT ENTITLED CREEK RESTORATION"; AUTHORIZING THE MAYOR, DESIGNEE, AND THE CORPORATION SECRETARY EXECUTE AND DELIVER, FOR AND ON BEHALF OF THE CITY, THE COST SHARE AGREEMENT BETWEEN THE ST. JOHNS RIVER WATER MANAGEMENT DISTRICT AND CITY OF JACKSONVILLE; PROVIDING FOR CITY OVERSIGHT BY THE ENGINEERING AND CONSTRUCTION MANAGEMENT DIVISION OF THE DEPARTMENT OF PUBLIC WORKS; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2019-2020 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation

The funding above is a grant from the St. Johns River District ("SJRWMD") for Water Management its participation in the costs of the McCoy's Creek Improvement Project.

Section 2. Purpose. The purpose of this legislation is to appropriate new grant funds from SJRWMD for its participation in the project costs for the restoration of McCoy's Creek by enhancing the natural creek flow and natural flood plain, removing two bridges, raising two bridges above the 100 year flood stage, opening the mouth of McCoy's Creek, and transporting contaminated ash within a highly urbanized creek lying within the city limits on the north bank of the St. Johns River in proximity to the Fuller Warren Bridge.

Section 3. CIP Amendment. Ordinance 2019-505-E, being the 2020-2024 Five-Year Capital Improvement Program for the City and certain of its independent agencies, is hereby amended to use grant funds for the project entitled "McCoy's Creek Restoration." The project is more fully described in the Project Information Sheet, attached hereto as Exhibit 2 and incorporated herein by this reference. The Council finds that the deferral of this amendment of the CIP until the next annual budget and CIP review will be detrimental to the best interests of the community because such deferral will result in unnecessary delay in receiving grant dollars from SJRWMD. Pursuant to Section 122.605(c), Ordinance Code, enactment of this ordinance requires the affirmative vote of

two-thirds of the Council members present at the meeting because of the CIP amendment set forth in this section. This ordinance shall constitute an amendment to Ordinance 2019-505-E. In all other respects, the Five-Year Capital Improvement Program approved by Ordinance 2019-505-E shall continue in full force and effect.

Section 4. Approving and authorizing execution of Cost Share Agreement. The Mayor, or his designee, and Corporation Secretary are hereby authorized to execute and deliver, for and on behalf of the City, the Cost Share Agreement between the St. Johns River Water Management District and City of Jacksonville, in substantially the same form attached hereto as Exhibit 3 and incorporated herein by this reference.

Section 5. Oversight. The Engineering and Construction Management Division of the Department of Public Works will provide oversight.

Section 6. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
