1. Can you provide .kmz maps for all fiber routes, including fiber counts, available fiber (i.e., fibers for use by others per route), empty conduit, and access points?
2. With respect to the buried fiber plant, does the fiber share space with the electrical plant or is the fiber run through separate conduit?
3. With respect to the aerial fiber plant, is the fiber installed above the neutral in the electrical space? If the fiber is installed below the neutral, how far below?
