1. Approval - Jacksonville Waterways Commission Minutes for January 13, 2021.

The commission voted to approve the minutes from January 13, 2021.

- 2. Approval Wake Zone Committee of the Jacksonville Waterways Commission Minutes for January 22, 2021.
 - Report on Slow Speed Zones Jill Haskell

The minutes were approved for the Wake Zone Committee meeting from January 22nd. Jill Haskell gave an update on the most recent Wake Zone Subcommittee. Ms. Haskell said that the places where a minimum wake zone signs would be most needed are the Ortega River and Ft. George Inlet.

Marshall Adkison asked if there were wake zone signs needed around bridges. Ms. Haskell said that there are already signs around most bridges. Captain Suber clarified that most, but not all bridge locations are under slow speed zones. Mr. Adkison said that signage is needed around Clapboard Creek. Ray Pringle asked why there have been so many accidents in the Ft. George Inlet area. Captain Suber said it is due to congestion and the use of alcohol. Lane Burnett said he needed to withdraw his name as a member from the Wake Zone Committee for personal reasons.

St. Johns River Status Report on Water Quality and Manatees - Dr. White & Dr. PintoUpdate on Algae Bloom

Dr. White said that the water temperature has been much colder, under 60 degrees. There have been higher tides with significant rainfall and high salinity.

Dr. Pinto said there has been one recorded manatee death this year and one death is currently being processed. Both were due to cold stress. One manatee was recently saved.

Update from Visit Jacksonville

Katie Mitura, Director of Marketing Visit Jacksonville, spoke about the added accessibility updates to the brochures for the 7 Creeks Recreation Area. Ms. Mitura said that tourism has been down due to COVID-19 but has not hit Jacksonville as hard as other areas of Florida in terms of hotel vacancies.

Future of Water Taxi Routes

Heather Surface, St. John's River Taxi, showed images of docks along the St. John's River which showed the routes that the taxis use to bring people around Jacksonville. Ms. Surface talked about the impact COVID-19 has had on their ability to transport large groups in the water taxis.

Sandbar Dredging

Mark Devereaux went over the hands-on work he has done to detail the sandbar that has been created by dredging. Mr. Devereaux presented PowerPoint slides which showed the depths of the water currently, and historically going back to 2014. He noted that in the area it is sand and not mud which is new for the area. The impact that Mr. Devereaux noticed in the sandbar has happened in the last year. Mr. Devereaux said he would be able to bring in residents and boat owners that could testify that this sandbar is a new impact to the area. Chair Ferraro said that they will continue this discussion at next month's meeting. Captain Suber said he would follow up with FWC for possible emergency markings to be used for the area.

Boat Ramp Updates - 8505 Beach Blvd

Jill Enz gave an update on the boat ramp at 8505 Beach Boulevard. The report process has been finished.

Resolution "communications media technology" (CMT)

The Commission discussed the communications media technology resolution which, if passed, would allow for voting to be done over Zoom. Susan Grandin, Office of General Counsel, explained the resolution which would allow for voting via Zoom for the City's Boards and Commissions. This would allow for voting virtually if seven members of the

Waterways Commission are physically present in the chambers for the vote. Ms. Grandin gave a historical background of the commission. Mr. Adkison suggested adding death in family or once in a lifetime event be added as an "extraordinary circumstance". Mr. Pringle suggested adding family circumstance. The agreed upon term to add to the extraordinary circumstance was, "extraordinary family event or mandatory business obligation".

The Commission voted 8-0 to approve the resolution to be sent to the City Council from the Jacksonville Waterways Commission.
