Course Description

This 3-hour course, presented by the Office of Ethics, Compliance and Oversight and the Office of General Counsel is for Elected Officials in Jacksonville, Jacksonville Beach, Neptune Beach and Atlantic Beach plus City Council Administrative and Legislative Staff, members of the Jacksonville Aviation Authority Board and the Jacksonville Downtown Investment Authority Board. The course will cover a range of government ethics topics including state and local gift laws, financial disclosure filing requirements, Sunshine Law and Public Records requirements, campaign ethics, and rules governing the ethical use of a public position. The course will satisfy annual training required by the State of Florida for elected officials and local code requirements that City Council members and staff receive annual training on Florida's Sunshine Law and the Public Records Act.

TERRANCE FREEMAN, JACKSONVILLE COUNCIL PRESIDENT-DESGINATE

Council President-Designate Freeman earned bachelor's and master's degrees in physical education and sports psychology and is working on his Doctorate in educational administration. Mr. Freeman spent over ten years as a teacher, a school administrator, and coach.
