Recommendation to 2022-504 - Budget Bill

Decrease pay-go for roadway resurfacing by \$4,822,290 with the intent of using American Rescue Plan funding to replace this amount. Utilize the \$4,822,290 to fund a general fund contribution to the Disability Fund - General Employee (\$3,322,290) and to the Disability Fund - Public Safety (\$1,500,000) with the intent to not utilize American Rescue Plan funding for contributions to these funds.

Note - The net result will be the same funding to roadway resurfacing (total \$29 million) and a \$177,710 increase to the contingency within the American Rescue Plan Ordinance (2022-513) after actions are taken on the American Rescue Plan bill (Ord 2022-513) at a later date.
