- c. Revision of the Planning Commission Membership selection process
- d. Drainage
- e. Landfill space and funding

Sheri Webber, Council Member Carlucci's Executive Council Assistant, advised Council Member Carlucci that there were five minutes left before the meeting hard stop at 10:45 a.m. with one public comments card submitted.

Council Member Carlucci stated he would extend the meeting to allow the public to speak. Council Member Carlucci informed Council Member Clark-Murray that they needed to have a continuation meeting soon and expressed how he wants to contribute to District 9's top priorities as an At-Large Council Member.

Council Member Carlucci opened the floor for public comments.

John Nooney stated he attended the meeting because Council Member Clark-Murray is an alternate member of the Jacksonville Waterways Commission and expressed his concerns.
