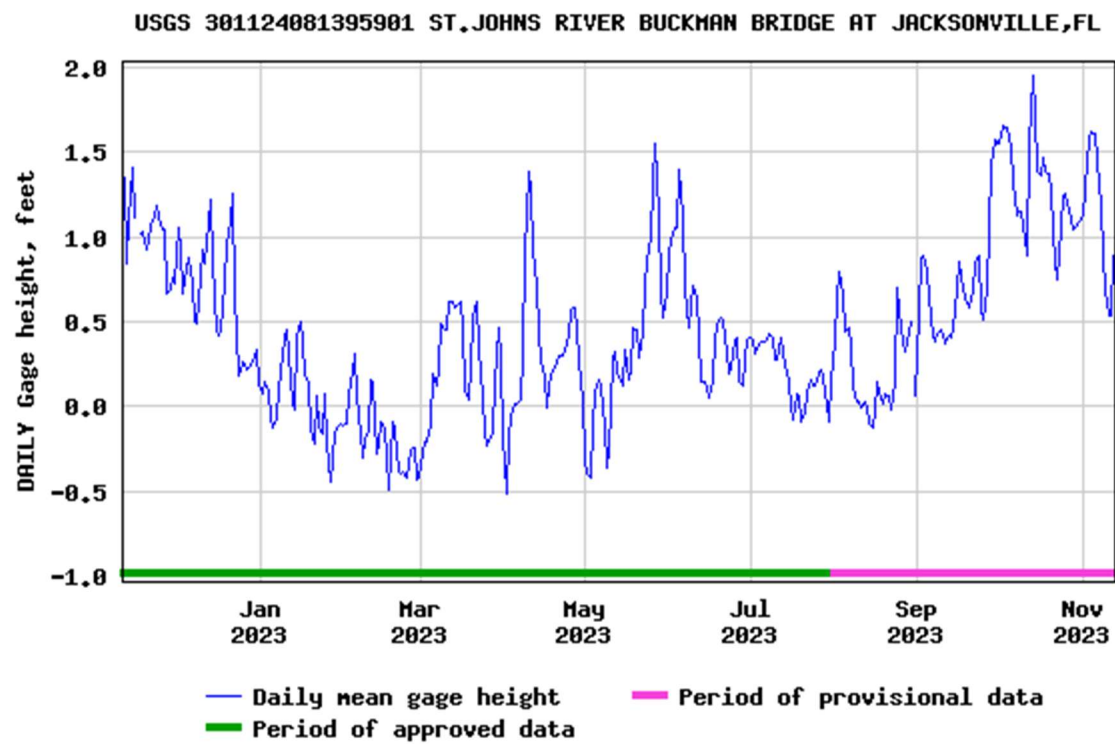

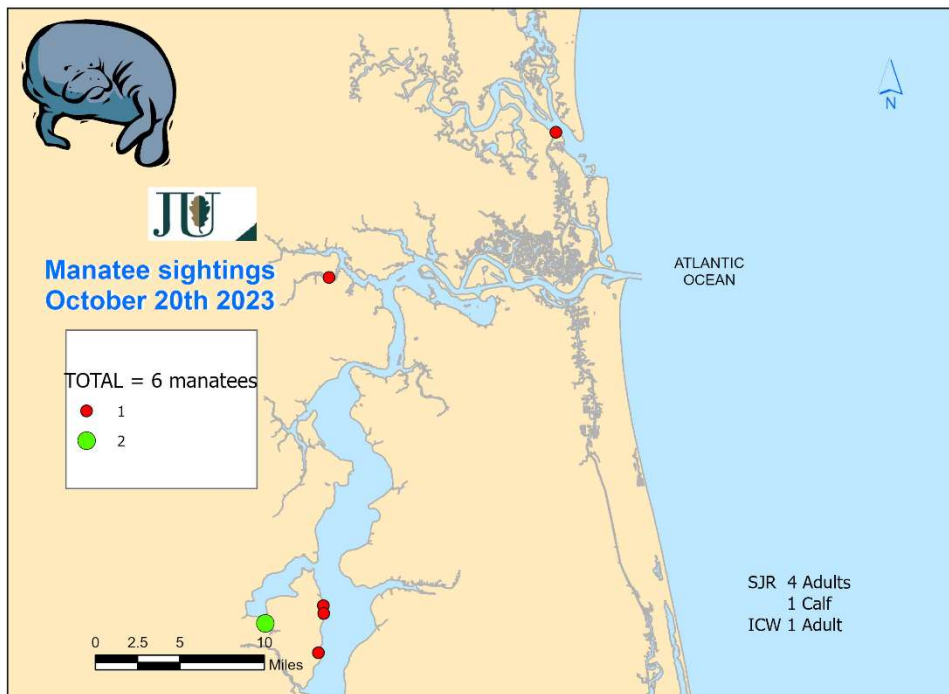

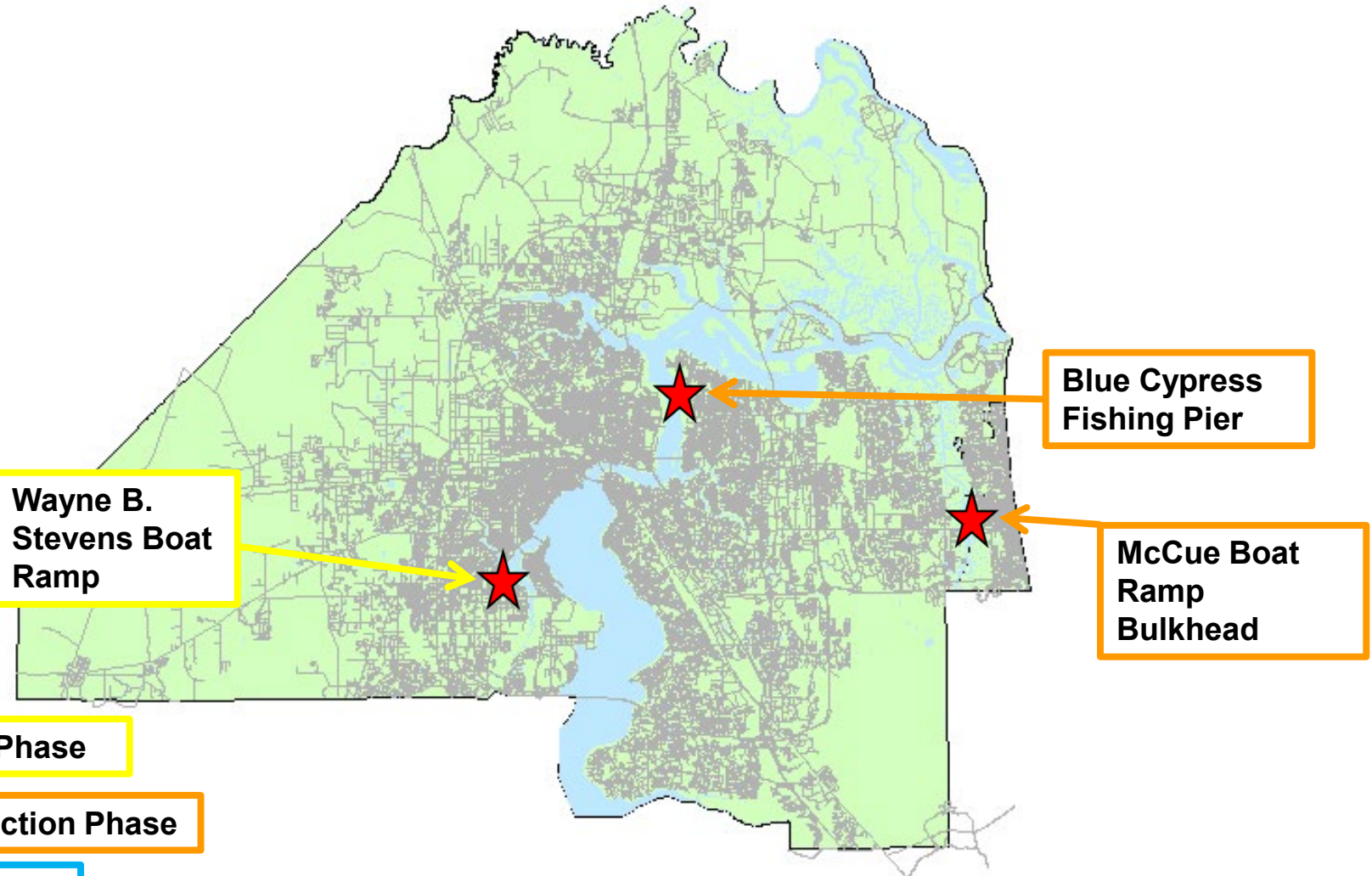

Location of 2024 Proposed FIND Projects

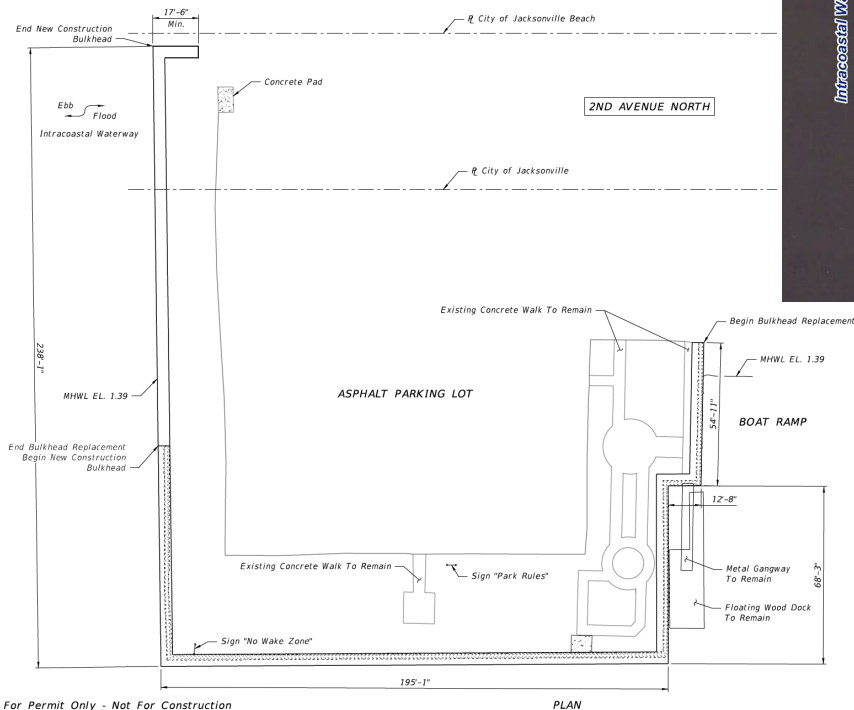

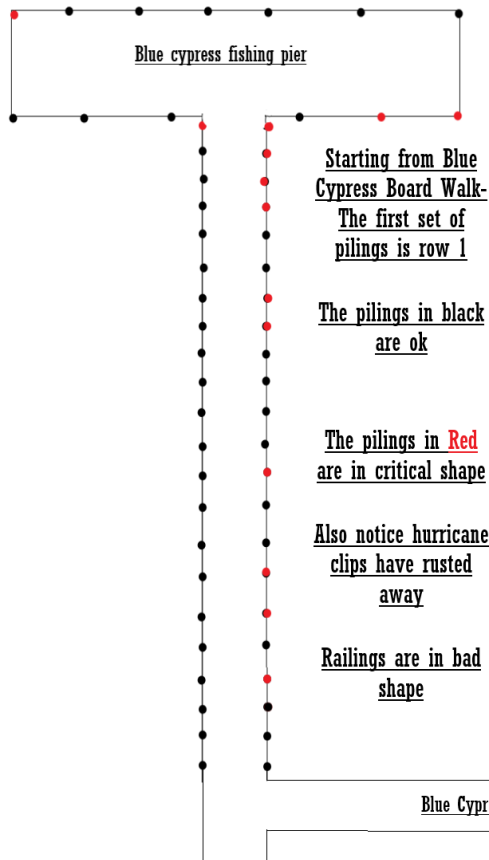
