Dr. Gerry Pinto reported that the recent increase in rainfall had cooled down temperatures, which posed a problem for manatees in the area. Five manatees were currently being held at the zoo, with three of them being recently saved. There had been seven recent manatee deaths, with the latest being most-likely human-related, as it showed signs of being injured by the lower temperatures externally but not internally.

Dr. Pinto reported on salinity levels at various points within the St Johns River system. He reported that water levels were currently about 1.5 feet above the normal level and that the upcoming expected rain could raise them further. He reported that there were no new reported algae blooms, although that did mean there was zero incidence of algae in the river system.

CM Peluso asked for clarification as to the protection status of manatees, and Dr. Pinto explained that the state Fish & Wildlife Conservation department had de-listed them from endangered to threatened but was re-evaluating that change based on a recent starvation event in the Indian River Lagoon.

Ed Lukacovic, Planning and Development Division, gave a presentation on the property affected by this zoning change. This ordinance would change a property on the southwest of Jacksonville in District 12 from Community General Commercial to Light Industrial. Mr. Lukacovic explained that this bill was going before the JWC because a creek runs through the corner of the property. He explained that there were no wetlands on the property that would affect the greater water table.

CM Gay noted that there was a pond at the south end of the property, and Mr. Lukacovic stated that this pond had no connection to the creek and was not technically a wetland.

Commissioner Fraden asked whether the developer or City had plans to remediate potential increases in stormwater run-off cased by industrial activity, and Mr. Lukacovic answered that there were no such current plans. Commissioner Fraden asked whether the City tests water quality at affected properties before and after zoning changes, and Mr. Lukacovic answered that while water quality is frequently test, it is difficult to pinpoint specific causes for any change in water quality.

Commissioner Barker noted that this property had at one point been a racetrack. Patrick Krechoswki explained that the property had been the "Jacksonville International Raceway." He noted that this light industrial use was consistent with the surrounding area and explained that the owner would treat stormwater run-off caused by this industrial activity.

The bill was unanimously approved by the commission.

CM Peluso announced that 2023-0868 would be taken up at the beginning of the agenda.

Brian Burket, Waterfront Project Manager, explained that this bill would establish an agreement between the City, Jacksonville University, and OCEARCH, a global non-profit organization conducting shark research, to authorize JU and OCEARCH to use a City-owned dock at Mayport for the docking of the OCEARCH research vessel. He stated that the construction of the dock is nearly complete and that this bill would formalize a 30-year lease for JU and OCEARCH's use of the dock. Dr. Quinton White of JU thanked the commission for its consideration of this bill and stated that this agreement would be

Commissioner Devereaux asked for clarification as to who was responsible for maintaining the dock throughout this 30-year agreement, and Mr. Burket answered that the City would be responsible for maintenance.

The commission orally approved the bill.

a. St. Johns River Shoaling Task Force Update

CM Gay gave an update on the St. Johns River Shoaling Task Force. He stated that dredging had begun in the area and that he had reached out to representatives in both the state legislature and in Congress, hoping to communicate to them that this is a regional problem and not simply a City problem. He explained that the City needs an active funding source to solve this problem and that various stakeholders from the region need to be involved in order to achieve this goal.

CM Peluso asked whether CM Gay had met with the Army Corps of Engineers, and CM Gay stated that he preferred to meet with state and federal representatives first.

Commissioner Birtalan asked whether it would be helpful if someone who lived near the dredging took a water sample to test for sediment, and Dr. Pinto responded that it would be difficult to use such information scientifically.

Commissioner Devereaux noted that the City expects two inches of rainfall this weekend and observed that this could be an opportunity to videotape how water flows from the site. He offered to enter this video into the record at the next meeting. CM Peluso clarified with Rita Mairs, Office of the General Counsel, that this would not be an issue. Commissioner Hardesty stated that he had previously distributed similar evidence via email, and CM Gay suggested sending such evidence to the Office of the General Counsel's representative to avoid any potential Sunshine issues. Jim Suber, Waterways Coordinator, noted that Commissioner Devereaux's offer to videotape the flow of water under the bridge would be useful.

Commissioner Haskell stated that she also had evidence and noted that it might be useful to put together a collage of evidence to show a timeline of how the dredging has affected the area. CM Gay stated that a timeline would be a useful exhibit when meeting with state and federal representatives, and he suggested to the Office of the General Counsel's Waterways representative. CM Peluso noted that the shoaling taskforce is open, and commissioners may attend these meetings to give additional input regarding how to proceed in solving this issue.

Ms. Mairs noted that Shannon MacGillis would be taking over for the Office of the General Counsel on the JWC in the near future and would function as this point of contact.

b. River Accord Task Force Update

CM Peluso expressed that he was pleased with the attendance at the November 22 River Accord Task Force meeting. He noted that the next meeting will take place on January 19 at 10:00 AM in the Lynwood Roberts room. He noted that, with a new Basin Management Action Plan term about to begin, it is a good time to re-start the River Accord to ensure that Jacksonville's portion of the St. Johns River is as clean as possible.
