Bail Assistance

Through our National Revolving Bail Fund, we have posted \$84 million in bail assistance, helping over 28,000 individuals to return to their families, jobs, and communities, and to fight their cases from a position of freedom.



Court Appearance Support

Once our clients are free, we provide court reminders and transportation to court if needed. We've supported clients return to 106,402 court dates, for a 91% court appearance rate.



Community-Based Services

As part of our process, we ask clients about their needs and provide voluntary referrals to social service providers in the community. The most common service requests are for *mental health needs*.



Fairer Case Outcomes

The result is that 33% of Bail Project clients have all their cases dismissed. Through our client court appearances, 91% of our bail funds have revolved allowing us to support additional clients. We've prevented 1,185,596 days of incarceration and saved taxpayers \$92 million.
