#### **Executive Summary**

This is a Summary of the **2023** Manatee Protection Plan Implementation Report that reflects on the City of Jacksonville's efforts towards protecting manatees in Duval County. The third revision to the Duval County Manatee Protection Plan (MPP) was adopted by the Jacksonville City Council in 2014 and requires an annual report of the progress on implementation of the MPP. The MPP is a comprehensive planning document that addresses the long-term protection of the Florida manatee through law enforcement, education, boat facility siting, and habitat protection initiatives on a county-wide basis. The purpose of revising the MPP was to collect and evaluate updated information on manatee use and boat activity in the City of Jacksonville (COJ) and provide guidance targeted at reduction of human-related threats to manatees and manatee habitat. The MPP attempts to balance boater access to Jacksonville waterways with impact to manatees from boat traffic and is intended to increase the predictability of permitting outcomes for boat facility development.

The **2023** MPP Implementation Report is a compilation of the efforts of a wide variety of agencies that reflect the effort expended to protect manatees in Duval County waters. The report is divided into five (5) sections: Meeting Minutes, Law Enforcement Reports, Education, Awareness and Environmental Reports.

The Meeting Minutes subsection report is an assemblage of the appropriate minutes of the Jacksonville (Duval County) Waterways Committee. This section serves as a good review of the activities of the year and demonstrates the importance that manatee protection has within the City and JAXPORT.

The Law Enforcement Report subsection includes quarterly reports from Jacksonville Sheriff's Office Law Enforcement Task Force, Florida Fish and Wildlife Commission (FWC) Law Enforcement, and Multi-Agency Deployments. The City has improved communication and coordination between federal and state Law Enforcement agencies since the development of a L.E. Task Force in December of 2009 that has fostered improved efforts in manatee protection. The involvement of the City's Waterways Coordinator, a former JSO marine officer, has been very helpful in a variety of ways. His efforts have resulted in the buy-in of all law enforcement agencies and improved the coordinated multi agency deployment weekends.

The Manatee Education Report contains the extensive effort made on behalf of manatee protection within the City of Jacksonville. Included is the COJ's Park Naturalist Education Program, presentations made by Jacksonville University faculty on manatees, and the FWC Northeast Lab outreach programs. The City also completed a 30-second public service announcement broadcast in 2018/2019, but was not broadcast by local TV stations in 2020/21/22/23. JU also participated in the Florida Fin Fest at Jacksonville Beach in September that involved 27,500 people in attendance over two days.

The Awareness subsection contains the Updated Boat Facility Inventory, a list of DEP Dock permits, Manatee Mortality Information, along with Aerial Sighting Maps. It should be noted that three (3) flights/year are funded by the City of Jacksonville.

In summary, the MPP Implementation Report offers an up-to-date review of manatee protection efforts in the City of Jacksonville (Duval County).

# Manatee Data Report


<u>Aerial Sightings:</u> There was no Manatee State Synoptic Survey conducted in 2022/2023 due to warm winters and like 2021 because of COVID-19 restrictions. Other surveys (see the following Map Series A) in 2023 occurred during May and October. No survey was conducted in 2020, again due to a warm winter. During warm winters manatees do not congregate at warm water sources and are more spread out, making them difficult to count effectively. Surveys in 2020/21 coincided with a boating compliance study for 9 surveys from June 2020 to May 2021 (surveys were not feasible during three months –August and October of 2020, and February 2021. A synoptic survey of northeast Florida was conducted on February 28<sup>th</sup> (SJR) and 29<sup>th</sup> (ICW) 2019 and one animal was sighted in Pottsburg Creek near University Blvd. South. Subsequent surveys in 2018 occurred in May, and August. As in the past, synoptic surveys identified few animals in the area: On February 1<sup>st</sup> 2017 a synoptic survey reported 6 animals sighted in the area. Other surveys in 2017 occurred in May, and September. In 2016, a synoptic survey on February 12<sup>th</sup> reported no manatee sightings. Other surveys in 2016 took place in March, April, May, June, August and September. Similarly in 2015, a synoptic survey on February 16<sup>th</sup> reported no manatees sighted in the area with subsequent surveys occurring in April, June, August, October, and November.

The Single Highest Day Count (SHDC) of manatees represents the highest number of animals counted on a single survey day throughout the year. For the Lower St. Johns River (LSJR), the SHDC for 2023 was 59 manatees per survey in late May. In 2022, 76 animals per survey were observed in June representing an increase since to previous two years when 53 animals per survey were seen in June 2021, and 39 animals per survey in June 2020. The SHDC for 2019 was 54 animals per survey (May), and 23 animals per survey in May 2018, which was the lowest number ever reported. These low numbers are partly due to animals arriving late into the area, but also not staying, because of a lack of food resources. Severe drought in early 2017 followed by storms and hurricanes later in the year and through 2019, negatively impacted the grass beds, likely causing manatees to travel more for food outside the study area. In contrast, the SHDC for 2017 was 90 animals per survey (May) – which was also lower than 2016 and again probably due to a severe drought earlier in the year. In 2016, the SHDC was 217 animals per survey (May) – the highest count on recorded. In 2015 the SHDC was 155 animals per survey this time in June, and in 2014 it was 176 (June); 2013 it was 143 (July), and in 2012 it was 177 (May).

Since Hurricane Irma in 2017 the grass bed habitat has been slow to recover and manatee numbers on average have been lower. Less manatees on average were seen in 2023 (33 manatees/survey, 2 surveys) than the previous year. Mean manatee numbers in 2022 were (74 animals/survey, 2 surveys) which was higher compared to 2021 (30 animals/survey, 4 surveys); 2020 (34 animals/survey, 2 surveys); May 2019 (28 animals/survey, 2 surveys), and 2018 (11 animals/survey, 3 surveys). In 2017, the mean number was 33 manatees per survey (3 surveys), again lower than in previous years before Hurricane Irma. Compare this to 2016, the mean number of manatees 102 (8 surveys) and in 2015 averaged 57 (6 surveys). It is important to note that beginning in 2012 there was a shift in the emphasis of data collection towards assisting the law enforcement effort to protect manatees and educate boaters. As a result, sampling frequency was significantly reduced and focuses on those months when manatee presence in the area is at its highest. To reflect the shift in sampling frequency and focus, manatee data in this report was separated into these two periods (1994-2012 and 2013-2023).


In the Intracoastal Waterway (ICW) only one animal was observed in 2023, and the mean number of manatees per survey in 2022 was 3, compared to 4 (2020/21); 6 (2019), and 2 (2017/18). Slightly more manatees were observed in the past with 9 manatees per survey (May 2016), 5 manatees per survey (June 2015 and May 2014), 9 (April and July 2013). The period from 2013-2023 has a survey frequency (3 surveys/year; s.d.  $\pm 2$ ; range 2-7) and returned a general mean of **3** manatees per survey (s.d  $\pm 3$ ; range 2-9 animals).

Seasons were generally classified as follows with each map indicating the specific date when a particular aerial survey was conducted: Winter - December – February; spring – March – May; summer - June – August; fall - September – November.




MAP SERIES A – Manatee aerial sightings, Duval Co., FL. (June 2022)

Habitat: Line transect data from 2004-2011, and 2015-2023 indicated that there was a significant long-term decline in the grass bed total cover percentage at sites sampled in Duval County (SJRWMD 2023). There has been a limited recovery in 2023 of grass beds in some of the areas further to the south in the Lower St. Johns River Basin, but this continues to be below historic levels of the late 1990's. The recovery rate has been slower due to the physical damage from storms, increased water depths, reduced water clarity, and significant predation pressure on the plants (Pers. Comm. Dan Kolterman (FWC) 2023). Additional observations made during aerial surveys in 2015 and 2016 indicated that SAV returned to some areas previously reported to be devoid of grasses. Manatee were observed feeding in those areas. However, recent observations indicate that there are many bare areas with no manatees. Furthermore, recent storms and the resulting turbidity has hindered the recovery of this habitat. In 2017, 71% of 17 sampling sites in Duval County had no grasses, and in 2018, 56% of 16 sampling sites had no grasses. In 2019, there were 17 sites sampled, and 76% were devoid of grasses. From 2020, there was signs of recovery as the percentage of sites devoid of grasses declined slightly from 63% (16 sites sampled) to 59% in 2021 with 17 sites sampled. In 2022, 50% of 14 sampling sites were devoid of grass, indicating a slight improvement over time. In the past, aerial observation indicated that there had been a visible decline in the grass beds since 2005. Toxic algae blooms seen in the St. Johns River from 2013-2023 do not seem to have harmed any manatees.

<u>JEA District # 2 Outfall and North Side Generating Station (NSGS)</u>: No manatees were observed at the JEA District # 2 site during aerial surveys conducted by Jacksonville University from spring to fall of 2013 to **2023**. However, manatees continue to be seen in the vicinity of the JEA District # 2 wastewater treatment outfall's manatee exclusion barrier by JEA's contractor and others.

The lower frequency of aerial survey effort, especially during cold weather, was insufficient to document manatees at this site during the years 2009-2020. However, boat and land surveys by independent contractors indicated that manatees consistently make use of the site.

# <u>Jacksonville Port:</u> All signage and information pertaining to safety about manatees was updated 2023. This included an online brochure that was made accessible via QR code.

<u>NAS Mayport:</u> Mayport NAS initiated manatee awareness and reporting program in spring 2011. Signs were posted at intervals along Mayport basin, and a data log kept of sightings and actions. **No data was available in 2020/21/22/23.** As of September 2019, 30 animals were sighted (range 0-12/month). In 2018, 48 animals were sighted (range 0-19/month). In 2017, 59 animals were sighted (range 0-18/month). In 2016, 152 animals were sighted (range 0-48/month), and in 2015, 130 animals (range 0-44/month). Lower numbers were observed during 2013/14 with a mean of 65 (range 0-16), and during 2011/12 with a mean of 35 animals (0-13/month). **Typically, the highest counts were recorded in May and June**.

Duval Manatee Rescues: Two manatees were rescued in Duval County during 2023: One on 1/6/2023, but the animal expired later at the Jacksonville Zoo on 1/25/2023; the second was a calf by itself, rescued 6/1/2023 but died soon after while in rehab at Sea World. The Jacksonville Zoo and Gardens rescued two manatees in 2022, a male on 03/17/2022 was released the following day and a female on 08/26/2022. In 2021, the JZG rescued a manatee on 03/14/21; however, it expired shortly after. There were no reported rescues in 2020. In 2019, a manatee was rescued because of acute watercraft impact likely from a large slow-moving vessel (July 3<sup>rd</sup>), however, the animal died during transport to the rehab facilities. A second animal was rescued at Mayport due to cold stress (November 21st, 2019) and later released in the Indian River (January 29th 2020), and a third cold stressed animal was rescued at Huguenot State Park (November 26<sup>th</sup>, 2019) but was nonresponsive and expired at the scene . In 2018, on March 18th a manatee (Vilanzo) was captured suffering from cold stress, rehabbed at Jacksonville Zoo, and successfully released on May 15<sup>th</sup> at Oak Harbor boat ramp (ICW). Also, on March 22<sup>nd</sup>, 2018, a male manatee was rescued from Miller Creek, it was stuck in the mud and cold stressed. In 2017, on February 7<sup>th</sup>, 2017, a male manatee was rescued from Ortega River. On March 31<sup>st</sup> a female manatee was rescued from Pablo Creek, both manatees exhibited symptoms of cold stress. Furthermore, three manatees were assisted and released on 1<sup>st</sup> June (Pablo Creek), 2<sup>nd</sup> July (intake canal JEA NSGS), and a calf on September 11<sup>th</sup> near Wayland Street opposite Talleyrand docks. On December 16<sup>th</sup> a female calf was rescued in the San Pablo River, she was beached by herself and cold stressed. In 2016, two manatee rescues were

performed at JEA's NSGS. "Stokes" was rescued on Jan 27<sup>th</sup>, and another animal on March 7<sup>th</sup>, both animals were taken to Sea World of Florida due to cold stress related issues. On November 30<sup>th</sup> a female manatee was rescued from a storm drain near Davinci Ave. also transported to Sea World. There were <u>no</u> reported assists or rescues as of September 2015. In 2014, six manatee rescues occurred during cold weather from (JEA District #2 outfall, Green Field Creek, Mill Cove, San Carlos Creek, and Cut Creek).




Figure 1. Florida manatee mortality. Total deaths (green), watercraft deaths (yellow); and five-year running average of watercraft deaths (black dotted line).




Figure 2. Duval County manatee mortality. Total deaths (green), watercraft (yellow), and fiver-year running average of watercraft deaths (black dotted line).

### **Manatee Mortality**

<u>Manatee Mortality:</u> In Duval County, the five-year running average of watercraft mortalities showed a decreasing trend since 2012 (in contrast, that of the State continued to increase). Since 2014, the frequency of times that the watercraft death rate (watercraft percent of total mortalities) was higher than that of the State rate has decreased (with three exceptions 2017, 2019, and 2023).

<u>Large Vessel Manatee Mortality</u>: Several large vessel caused deaths were reported over the past years. From 2009 to 2013, more watercraft deaths were documented towards the mouth of the river, rather than a more countywide spread as in prior years. Manatee deaths occurred in an area extending from Downtown to the mouth of the St. Johns River. Recently in the last few years, there have been some deaths south of downtown, particularly in the Ortega River area. From 2019 to 2022, the number of deaths was lower overall, but this may have been due to fewer manatees in the area (Map Series A). In May of 2022, there was a single watercraft caused manatee mortality in the Ribault River, but the vessel size was undetermined.

In 2023, a possible mating group of five manatees was hit by what was likely to be a large vessel or vessels entering the Jacksonville Port near Blount Island Terminal. On Friday 12<sup>th</sup> May 2023, the first Post Panamax vessel entered Jacksonville Port followed by a flotilla of other watercraft. In the days following this event five manatee carcasses were recovered in the vicinity. The animals displayed signs of trauma ranging from blunt force trauma to transected carcasses consistent with that of a large propeller from possibly a tug, ship, or mega yacht (see following table and Map Series B).



#### SERIES B – Manatee mortality, Duval Co., FL. 2022.





### **Marine Facility Inventory Summary**

#### Boat Launch Facilities Signage Inventory:

An inventory of signage was completed and there were no changes to report since the previous year. The database of all local manatee, boating safety signage, and information kiosks at boat ramps in Duval County is current and up to date. <u>Methods:</u> Researchers visited all facilities to record and verify information.

#### Marine Facilities Inventory:

This inventory includes ~192 commercial and multi-family marinas and docks, which were checked over the boating season (June-September). Changes in the number of wet and dry slips from the previous year are indicated. Ther was a decrease in the number of wet slips from 3,584 in 2022 to 3,304 in 2023 (change -280). Dry slips decreased from 2,795 in 2022 to 2,730 in 2023 (change -65). There was a total of 60 ramps and 962 parking spaces from 2022 to 2023.

<u>Methods</u>: Researchers placed phone calls to individual facilities to obtain information about the occupancy and capacity changes if any. After that, researchers visited a subsample of these facilities to verify information. Some data was verified using digital video footage taken while conducting manatee aerial surveys.

# **In addition, 77 single-family home dock permits, plus 1 dock rebuild permit was issued in Duval County 2021/2022, compared to 76 dock permits ( plus 2 docks rebuilt) in 2020/21. This subinventory includes tracking of development slips specific to the downtown DRI area. Note that as of 2023, 218 slips have been constructed, and 728 have not been constructed.



#### **Downtown Marina Slips (August 2023)**

\*Previously, these slips were no counted as "allocated" in the Manatee Protection Plan. The Florida Fish and Wildlife Commission (FWC) has now required the City to account for these slips as "allocated." State has been petitioned to reduce this number by 10 slips due to revised measurements of linear transient slips. \*\*These slips are entitled to the City / DIA and may be reallocated to other areas of Downtown by DIA Resolution and City Council Ordinance.

In addition to the sub inventory, Downtown public docks include:

- 30 slips Northbank/Landing (pre-existed 1999 MMP and rebuilt in 2021)
- 2 slips Southbank/Chart House (original dock pre-existed 1999 MMP; rebuilt with 2014 SBRW)
- 2 slips Southbank/Dinner Cruise dock (original dock pre-existed 1999 MMP; rebuilt with 2014 SBRW)
- 2 slips A. Philip Randolph Blvd. dock (originally built around 2007 and expanded in 2017; City owns submerged land; need to be allocated?)
- 10 slips RAM dock
- 5 slips Friendship Fountain Dock
- 10 slips Riverplace Tower Dock
- 5 slips Jackson Street Dock
- 3 slips Baptist/Fuller-Warren Dock (currently in design)



### Waterways Commission Meeting Summaries

The Jacksonville Waterways Commission was established in 1984 to study and make recommendations to the City Council with respect to the improvement, development and protection of the St. Johns River and all tidal waters in Duval County. The Commission is charged to formulate an overall plan for dealing with any problems that exist the St. Johns River and Duval County tidal waters and devise methods of developing future uses of those waterways.

The Commission serves as the Duval County committee to review rules proposed by the Florida Fish and Wildlife Conservation Commission governing speed and operation of motorboats to protect manatees. And acts as a coordinating agency and specialized advisor for governmental units and for programs and activities affecting the improvement, development and protection of the St. Johns River and all tidal waters in Duval County.

#### DATE DISCUSSION

October 12, 2022 Dr. Pinto said there has been high levels of salinity and an increase in flood water. Dr. Pinto said that algae should be less of an issue than in the summer. Mr. Fraden asked when we can expect the flood waters to go down. Dr. Pinto said that it is difficult to say when the flood waters will go down. Dr. Pinto said there have been no more manatee deaths since the last meeting, leaving the total as of this year at 7 manatee deaths.

#### November 2022 No meeting.

- **December 14, 2022** Dr. Pinto gave an update on water quality and said that water levels are running approximately one foot higher than normal. The water has been cooling and could have impacts on manatees. Dr. Pinto talked about the rehab program for manatees at the zoo. Mr. Hoyles asked about the experiment with clams. Mr. Adkison said he will give a presentation on this project at the next meeting. Jacksonville University Manatee Protection Plan Contract Renewal Eric Hinton, Community Planning Eric Hinton explained the changes to the plan and the actions within the plan. He confirmed that this is the last renewal on the contract.
  - January 12, 2023 Dr. Pinto said there has been 1 inch of rainfall accumulation this year and no algae bloom so far this year. There has been one manatee death this year on January 8th and another manatee was rescued on January 6th and is rehabbing at the Jacksonville Zoo. Updating Oyster and Shellfish Harvesting Mr. Adkison gave a presentation which updated the Commissioners on the oyster and shellfish harvesting. Dr. Jeremy Stalker, Jacksonville University, talked about the analysis process, the proposal to study the shoaling and the permits what would be needed.

# **February 15, 2023** Dr. Gerry Pinto with the Jacksonville University Marine Science Research Institute (MSRI) gave his monthly report on temperature, salinity and volume flow in the St. Johns River at various monitoring stations. He reported that there have been 2 recorded manatee deaths this

year, both due to cold stress. He noted the upcoming Rock the Docks fundraising event on the JU riverfront which raises funds for the MSRI, Ocearch shark research, and the JU rowing and sailing teams. Marshall Adkison asked about the current dock construction in Mayport that will be the site of the permanent home port for the Ocearch research vessel. Dr. Pinto said there is construction of new docks in Mayport, but not for the Ocearch vessel since the Florida Legislature's appropriation for that project was vetoed by the governor. Another bill for that funding will be filed in the upcoming session. Captain Suber said the docks currently under construction will serve the shrimp boat fleet and will accommodate some recreational vessels. Should the funding be obtained for the Ocearch dock, the new dock under construction will be extended to accommodate that vessel.

- March 22, 2023 Dr. Gerry Pinto from Jacksonville University's Marine Science Research Institute gave the monthly St. Johns River and manatee update. Salinity in the river remains high, which is normal for this time of year given the low rainfall. The water temperature is still cold for manatees; there have been 3 manatee deaths so far this year, all suspected to be from cold stress. The manatees will begin returning in April as the water warms Dr. Jeremy Stalker from Jacksonville University's Marine Science Research Institute made a presentation on his proposal for performing a study on the growing shoal at the mouth of Clapboard Creek near Blount Island. He described the complex tidal flows in the area of the channel behind Blount Island near the creek mouth. The aim of the study would be to identify the nature and source of the material causing the shoaling by analyzing the shoal's sediment composition, water flow patterns in the creek and river, and the physical form of the shoal. Side-scan sonar would be used to analyze the depth and form of the river bottom and the shoal. An Acoustic Doppler Current Profiler (ADCP) would investigate water velocity and flow patterns in the area. Staff would build a baseline profile of conditions in the area and then run tests on a monthly basis to observe changes. They would particularly sample before and after tropical storm events to determine the impact of those storms on the siltation process. A hypothesis about where the shoal material might be originating (a nearby dredge spoil disposal site is one candidate) can be tested by depositing specially made glass ultraviolet-reactive tracer sediment grains in the suspected source and then testing to see if they are eventually deposited at the shoal site.
  - April 12, 2023 Dr. Gerry Pinto of Jacksonville University's Marine Science Research Institute gave the monthly report. The water level in the St. Johns River is running a little higher than normal. The river's salinity readings have been interesting in recent weeks, showing lower salinity at the mouth than further upriver which is unusual. The cause is more rain falling nearer the coast than inland and therefore more dilution than usual near the river's mouth. Area rainfall is at a slight deficit for the year. There has been no change in manatee deaths since last month, with 3 recorded for the year. There have been a couple of reports of algae being seen in Doctor's Lake and in the main stem of the river in that area, but no serious algae bloom at this point. Adam Hoyles asked about the condition of the manatees in Indian River Lagoon and the FWC's feeding program. Dr. Pinto said fewer manatees are being rescued this year suffering from starvation than was the case last year, but the situation is still dire. There is some evidence that grass beds are regrowing somewhat both in the Indian River and in our area and there is hope that the beds will recover somewhat during the summer growing season.
  - **May 10, 2023** Dr. Gerry Pinto of Jacksonville University's Marine Science Research Institute gave the monthly report. Salinity in the river is back to normal after some unusual patterns in the last couple of months. Water temperature up to 75 degrees and climbing. Water levels are normal although rainfall is running 1 inch below average for the year. The city is normally fairly dry at this time of year and is a little drier than usual on the Westside. Manatees have begun returning to local waters and there have been no new deaths since the last commission meeting, with a 3 total for the year. There will be a Manatee Task Force meeting on May 19th comprising local and state law enforcement agencies to assess manatee boating regulations and enforcement. There will also be a media day for the opening of boating season on May 24th to raise awareness among boaters of manatee safety. Some algae is being identified upstream in the river near the Shands Bridge and Doctors Lake, but thus far nothing toxic has been identified. Commissioner Barker asked if anyone should be notified when citizens spot manatees. Dr. Pinto said citizen information is very useful and there's a manatee telephone

hotline (904-745-7575) or email (gpinto@ju.edu) to report sightings. He said he will be flying next weekend for an aerial manatee count, but that only identifies about 60% of manatees in an area. It helps to have input from the public to identify those not seen from the air. Chairman Howland asked if citizens should report all manatee sightings or just those sick or injured. Dr. Pinto said reports of all manatees sighted are useful, along with details on their location, number sighted, their behavior, etc. Citizens can call the Florida Fish and Wildlife Conservation Commission's hotline to report injured manatees, or any injured wildlife. Commissioner Fraden said he is aware of a donation of manatee warning signs and asked if he could voluntarily post them where manatees are sighted. Captain Suber said he would have to check on what is allowable.

- June 14, 2023 Dr. Gerry Pinto of Jacksonville University's Marine Science Research Institute delivered the monthly report. Dr. Pinto participated in an aerial survey of Jacksonville and spotted 59 manatees, with none in the intercoastal waterway. There were six manatee deaths in the past month, including five watercraft-related deaths around Blount Island and one calf death due to abandonment by its mother. This brings the total deaths to 11 for the year. Dr. Pinto also noted that the river's salinity is high despite heavy rainfall. Dolphin activity is abundant and the temperature is significantly increasing. Fortunately, no toxic algae blooms have been reported yet, even though conditions are optimal for algae. Commissioner Fraden highlighted the extraordinary circumstance of five manatee deaths within one mile. Adam Hoyles asked about a progress report on sea grass. Dr. Pinto responded that recovery is underway, with a promising exclusionary study also taking place. Commissioner Redick asked if the manatee deaths occurred in grassy areas, to which Dr. Pinto replied that the manatees were found around Blount Island, which is deeply dredged. During mating season, manatees can become disoriented and lose track of their location. In response to Commissioner Devereaux's question about the benefit of a public service announcement campaign, Dr. Pinto mentioned past PSAs, including manatee maps displayed on weather reports by Tim Deegan. Captain Suber added that these maps are distributed to boating groups to ensure awareness. CM Randy DeFoor asked about possible corrective action, to which Commissioner Devereaux remarked on the frequency of ships passing through.
  - July 2023 No meeting.
  - August 2023 No meeting.
- September 14, 2023 Dr. Pinto gave a brief report on the water quality in the river. Chair Peluso asked about causes of algae blooms. Dr. Pinto said blooms are caused a combination of nutrients, heat and rain, impacted by environmental factors like septic runoff, pesticides and wildlife. Dr. Pinto mentioned the symposium at UNF on October 13th, at which this year's State of the River Report will be presented.

October 12, 2023 Dr. Gerry Pinto of the Jacksonville University Marine Science Research Institute said the salinity of the river can change very rapidly depending on heavy rainfall, as it did today after several inches of rain fell. Water levels have been running above normal because of the rainfall as well and rainfall may exceed the average annual rate by year's end. Dr. Pinto said some toxic algae has been identified in Doctor's Lake but not in the main stem of the river. There has been 1 manatee death reported since last month, making 15 total for the year, of which 6 are from boat strikes. He announced the annual Environmental Symposium taking place at UNF tomorrow at the Adam Herbert University Center beginning at 8:30 a.m. There is also a WJCT online symposium on the State of the River Report on October 16th at 4:00 p.m.

## Law Report Summary

Good coordination and communication with the law enforcement agencies responsible for enforcing manatee speed zones within the county is an essential element of manatee protection. Although the City has minimal data to compare to previous years, the continued tracking of law enforcement efforts will allow the City to provide better analysis in future implementation reports.

The L.E. Task Force meeting is a valuable method for all law enforcement agencies to communicate and coordinate efforts. All federal, state, and local agencies are committed to assisting the City in boating compliance. The L.E. Task Force met on May 19 and JSO Media Day occurred May 24, 2023.

#### A. Jacksonville Sheriff's Office

In 2018, JSO spent 7,280 hours patrolling manatee zones. This represented an increase of 3,983 hrs. (+55%) from the previous year. In addition, JSO issued 23 citations (+91%, 21 more than in 2017), and 1,400 warnings (+62%, or 863 more than in 2017). The Marine Unity had 8 patrol officers on duty, (6 more than in 2017).

JSO 2018.

In 2019, JSO spent 7,245 hours patrolling manatee zones. This represented a decrease of 35 hrs. (-0.5%) from the previous year. In addition, JSO issued 25 citations (+8 %, 2 more than in 2018), and 986 warnings (-30 %, or 414 less than in 2018). The Marine Unity had 8 patrol officers on duty, (same as in 2018).

#### JSO 2019.

In 2019, patrol effort on the water decreased by about 0.5 % from 2018 (still 8 officers like in 2018) but remained relatively high compared to 2017 and prior years. In summary, from 2015 to 2019, JSO hours on the water patrolling manatee zones increased from 1,692 to 7,245 Hrs. (+328 % or +5,553 Hrs.); citations issued increased from 7 to 25 (+257 % or +18); and warnings increased from 16 to 986 (+6,063 % or 970 warnings). In addition, the number of available officers increased from 3 in 2015 to 8 in 2018 (+167 %). Moreover, specific manatee related incidents increased from one in 2015 to 26 in 2019 (+2,500%).







This issue causes confusion as to where the actual zone is making it a hindrance to enforcement. The issue was reported to FWCs Boating and Waterways Section.



This area marks the location between Reddie Point and Blue Cypress Park where one manatee zone marker is missing and another is off station (1000ft Buffer zone and marker is more like 300ft). This issue has caused confusion as to where the actual zone is, making it a hindrance to enforcement for the last 7 years. The issue was reported to FWCs Boating and Waterways Section.



This area marks the location between Arlington Marina and Jacksonville University where a manatee zone marker is missing (1000ft Buffer zone on two pilings). This issue has causes confusion as to where the actual zone is making it a hindrance to enforcement for the last 4-7 years. The issue was reported to FWCs Boating and Waterways Section.

From 2015 to 2017, total hours on the water patrolling manatee zones have decreased from 259 to 240 (-7%); citations have decreased from 16 to 3 (-81%); however, warnings issued have increased from 12 to 112 (+89%). There was no report available for 2018, 2019, 2020, 2021, and 2022.

# **EDUCATION SUMMARY**

Manatee education for both students and adults continues to be an important objective of Duval County's Manatee Protection Program. Education and outreach include the development and distribution of the Boating and Angling Guides, community manatee educational talks, participation in community festivals and other events, and transmitting information to the public via the PSA on local T.V. The stations that have the video for their PSA rotation include WJXT4, Fox30, CBS47, and CW17. The PSA is aired when there is available space/time determined by the T.V. stations. All outreach programs in 2020/21/22 were reduced due to COVID.

### Florida Fish and Wildlife Commission - Public Outreach

Over 1,567 people were involved in the FWC Community Outreach programs and events, compared to 1,172 people in 2022. The events ranged from v irtual and in person School based education programs to Zoo, summer camps and festivals.

### City of Jacksonville Parks Naturalist - Nature Walks and Talks

No information was available for 2022/2023 due to changes in personnel. From October 2020-September 2021, a total of 161 people attended 152 hrs. of walk and talks discussions (n=69) by the Parks Department Naturalist (October 2019-September 2020: 125 people, 206 hrs., n=54).

### Jacksonville University - Public Outreach

In 2023, outreach and education extended to about 7,633 people in total. In 2022, ~1,931 people (excluding digital media, TV, Radio, and Times Union newspaper) attended JU manatee education talks for a variety of schools and community groups compared to 2021 (1,998), 2020 (3,106), 2019 (4,895), 2018 (3,389), and 2017/2016 (3,081 and 1,179, respectively).

In addition, about 3,500 people attended the Jacksonville Science Festival at Metro Park (2 weekdays 2,500, and 1 Saturday 1,000), and the attendance at Fin Fest at Jacksonville Beach was 27,500 people, compared to 25,000 in 2022, over the weekend (2 days).

### Public Service Announcement (PSA)

Clear Channel reported that The Manatee PSA was conducted as a digital PSA program. The program ran for April-June 2019 and has not run since. Clear Channel provided 23,174 eight-second digital spots:

### AWARENESS SUMMARY

- Created PSA was not aired in 2020/2021/2022/2023.
- JSO held Media Day to stress safe boating and to be aware of manatees in the area (April 2023).
- Dr. White does a monthly newspaper column with FTU and has discussed manatees.
- Dr. Pinto conducted 2 manatee aerial surveys (There was no State Synoptic Survey in 2023).
- In addition, 72 single-family homes dock permits were issued in Duval County (2022/23), as compared to 77, +1 rebuild (2022) 76, +2 rebuilt (2020/21), 51 (2019/20), 25 (2018/19), 82 (2017/18), 64 (2016/17), 65 (2015/16), 59 (2015) and 71 (2014) (Source: SJRWMD 2023).

A total of **two (2)**-manatee sighting flights were conducted over the county to determine movement patterns of manatees (there was no State Manatee Synoptic Survey conducted in 2022). The information is provided to stake holders including Jacksonville Waterways Commission, law enforcement (Federal, State and County). Stake holders include entities such as Jacksonville Port, P1 boat race that may host run a boat race in June in the waters south of downtown, and the media (Florida Time Union, First Coast News and Others). In addition, local FWC Marine Mammal Recovery Unit personnel are notified about the latest manatee sightings report and map.

In 2019/2020 and 2021, the number of manatee observations was lower than usual due to major storms/hurricanes developing from as far back as 2017 – having deleterious effects on the submerged vegetation food supply. In 2022 and 2023, manatee population numbers in the area showed signs of recovery, however, the grass bed habitat remains significantly reduced.

Just like in Lee County, Florida (Semeyn, et al. 2011) the manatee count and distribution information in the form of maps is disseminated to local, state, and federal law enforcement, maritime industry groups, the port, and the media so that efforts can be focused on raising public awareness through education.

26 Section 8. Reports. Annual reports shall be submitted by 27 Groundwork to the City's Environmental Protection Board on September 28 15<sup>th</sup> of each year through September 30, 2025. A final report shall 29 be submitted at the conclusion of the Project.



**Bill Summary:** The bill appropriates \$122,091 from Environmental Protection Fund fund balance to provide funding for a direct contract with Groundwork Jacksonville, Inc. to undertake a pilot project in Hogan's Creek to determine the impact of stream restoration to natural conditions on water quality and the ability to obtain water quality credits. (**NOTE** – the appropriation is intended for a project on branches of McCoy's Creek; the scrivener's error listing Hogan's Creek as the site in the bill title will need to be corrected in committee). The funds are authorized to carry-over to FY24-25. The bill invokes the Procurement Code's exception to permit direct contracting with an organization specifically named in authorizing legislation and authorizes execution of a funding agreement between the City and Groundwork Jax. A provision of Ordinance Code Chapter 110 – City Treasury – is waived to permit a partial advance payment of the funds to be made to Groundwork Jax. The Environmental Quality Division of the Neighborhoods Department is designated as the oversight agency for the project. The funding agreement will contain a requirement for annual progress reporting by Groundwork Jax in September of each year through the end of the grant period.

**Background Information:** The pilot project will attempt to demonstrate the amount of water quality improvement and water quality credits that could be obtained by restoring artificially channeled streams to their natural condition as part of the larger McCoy's Creek restoration project. If successful, the results of the pilot project could be used to inform water project permitting processes by the St. Johns River Water Management District and Florida Department of Environmental Protection in other jurisdictions. The procurement exception and Ordinance Code waiver are required to enter into a non-competitive direct contract with the organization. The Environmental Protection Board has authorized the use of EPB funding as a worthwhile and beneficial use of the funds for environmental research.




#### Mike McCue Boat Ramp Bulkhead







**Bill Summary:** This bill authorizes the Mayor to apply to the Florida Inland Navigation District ("FIND") for 2024 grants to undertake specified waterways-related projects. It acknowledges the City's willingness to meet funding requirements and designates the Department of Parks, Recreation and Community Development as the oversight department for the project.

**Background Information:** FIND solicits grant applications from counties within its jurisdiction to undertake waterways-related projects. FIND grant applications must be accompanied by legislation acknowledging a county's willingness to meet the matching funding requirements, and the Department of Parks, Recreation, and Community Services has compiled a list of recommended grant projects for submission, with the approval of the Jacksonville Waterways Commission and the community.

The list recommended by the Department of Parks, Recreation, and Community Services and approved by the JWC included three projects:

- Mike McCue Boat Ramp Bulkhead, which will replace the failing bulkhead at this boat ramp. The project is recommended for a FIND grant application of \$3,520,000 (\$1,600,000 FIND award request plus \$1,920,000 City cost).
- Blue Cypress Park Fishing Pier, which will replace the pier due to failing support pilings that have caused the pier to be unsafe. The project is recommended for a FIND grant application of \$1,265,000 (\$575,000 FIND award request plus \$690,000 City cost).
- Wayne B. Stevens Boat Ramp, which will replace a boat ramp and associated access pier in Ortega. This project is recommended for a FIND grant application of \$165,000 (\$75,000 FIND award request plus \$90,000 City Cost).


The three (3) recommended grant applications total \$4,950,000.00 (\$2,250,000.00 reimbursable from FIND and \$2,700,000.00 from City's match including internal engineering fees). If these applications are awarded by FIND, the grant agreements will require legislation to amend the CIP and MBRC authorization to execute the grant agreements.

FIND grants fund both the design and construction phase of projects as well as acquisition projects. The project development costs are shared 50% by FIND and the 50% by the City, with exception of acquisition projects which are 25% from FIND and matched by 75% from the applicant. Internal Public Works fees for these projects are an ineligible expense for reimbursement through FIND. Grant agreements allow two years to complete the project and the City can request one additional year, if needed. 

**Type of Action:** Authorization of the Mayor to apply for grant funds; acknowledgement of the City's willingness to meet funding requirements; designation of an oversight department

**Bill Summary:** This bill authorizes the Mayor to apply to the Florida Inland Navigation District ("FIND") for 2024 grants to undertake specified waterways-related projects. It acknowledges the City's willingness to meet funding requirements and designates the Department of Parks, Recreation and Community Development as the oversight department for the project.

**Background Information:** FIND solicits grant applications from counties within its jurisdiction to undertake waterways-related projects. FIND grant applications must be accompanied by legislation acknowledging a county's willingness to meet the matching funding requirements, and the Department of Parks, Recreation, and Community Services has compiled a list of recommended grant projects for submission, with the approval of the Jacksonville Waterways Commission and the community.

The list recommended by the Department of Parks, Recreation, and Community Services and approved by the JWC included three projects:

- Mike McCue Boat Ramp Bulkhead, which will replace the failing bulkhead at this boat ramp. The project is recommended for a FIND grant application of \$3,520,000 (\$1,600,000 FIND award request plus \$1,920,000 City cost).
- Blue Cypress Park Fishing Pier, which will replace the pier due to failing support pilings that have caused the pier to be unsafe. The project is recommended for a FIND grant application of \$1,265,000 (\$575,000 FIND award request plus \$690,000 City cost).
- Wayne B. Stevens Boat Ramp, which will replace a boat ramp and associated access pier in Ortega. This project is recommended for a FIND grant application of \$165,000 (\$75,000 FIND award request plus \$90,000 City Cost).

#### Policy Impact Area: Waterways access

**Fiscal Impact:** This bill pledges City funds for individual waterways projects that will cost the City \$1,920,000; \$690,000; and \$90,000 respectively.

#### What is the Small-Scale Derelict Vessel Removal Grant Program?

Derelict Vessels in District waterways can cause navigation safety and environmental problems. The District provides assistance funding up to \$150,000 per county per year to assist other governments with derelict vessel removal projects along the Atlantic Intracoastal Waterway and associated waterways within the District.


The Small-Scale Derelict Vessel Removal Program is a grant program established by the Florida Legislature and the District for the purpose of cooperating with government agencies or not-forprofits. The program is authorized by Section 374.976, Florida Statutes, and is administered under the provisions of Chapter 66B-2.015, Florida Administrative Code. The Florida Inland Navigation District carries out administration of the program on the East Coast of Florida.

# Who may apply for assistance funding?

Eligible not-for-profits, federal, state and local governmental agencies

having projects and responsibilities within the twelve counties of the District (Miami-Dade to Nassau Counties) may apply for funding.

# When should the application be submitted for consideration?

Proposals are accepted for financial assistance for the removal of derelict vessels within the District's waterways at any time during the year. The derelict vessel(s) must be located on natural, navigable waterways within the District's Waterways. (Rule 66B-2.003, F.A.C)

The applicant should identify the specific derelict vessels and have a current bid for removal for such vessels or have completed the removal of such vessels within the 6 months preceding the application, subject to eligibility under these program rules.

Applicant should submit FIND Form No. 05-01 (Small-Scale Derelict Vessel Removal Program), and FIND Form No. 01-06 (Small-Scale Derelict Vessel Removal Program – Project Cost Estimate). The applicant shall include a map clearly delineating the location of all vessels included in the application.

This Request for Proposals is ongoing. The District intends to announce contract awards roughly 30 days after the receipt date of a successful proposal. Contracts will be initiated within 30 days of an award announcement.

# What is the maximum amount of funding that an applicant may request?

Funding is limited to \$150,000.00 per county, per year, provided on a reimbursement basis only.

The District is authorized to provide up to 75% funding of the total project costs. The funding provided by the District shall only be allocated for removal of derelict vessels.

# What may an applicant use as the local match?

Cash and other grant funds are acceptable for the applicant's local matching funds. Note that in-house project management or administration costs are not eligible costs for matching costs.

### Derelict, Abandoned and At-Risk Vessel Database

The Florida Fish and Wildlife Conservation Commission launched a program to help prevent vessels in state waterways from becoming derelict. Through the At-Risk Vessel Program, FWC officers will collaborate with local sheriffs' offices and police departments to enter information about potential derelict vessels into a statewide database.
