City Council President Ron Salem called the meeting to order asked the attendees to introduce themselves for the record. President Salem said the purpose of this meeting is to allow interested Council Members to speak to their qualifications for Council Leadership positions. President Salem stated that he has appreciated CM Carrico's diligence and enthusiasm as Land Use and Zoning Committee Chair, a position in which CM Carrico has demonstrated great leadership skills. President Salem opened the floor for comments.

CM Carrico stated that he believes the Vice President's role is about service to the President and covering whatever they ask of the Vice President. He considers himself a leader with management skills and listed his experience: Vice President of the Boys and Girls Club for the last eight years, and prior to that, he served as Vice President of Operations at the Clara White Mission.

CM Amaro said he likes CM Carrico and his fairness and his willingness to let the discussions and processes of the LUZ committee play out in the right timeline.

CM Joe Carlucci said he appreciated CM Carrico's leadership during his time on LUZ thus far.

CM Clark-Murray said she appreciates the way CM Carrico runs the LUZ meetings. She asked if CM Carrico foresaw any conflicts if he were to become Council President. CM Carrico said he is confident any conflict that could arise would be handled by the Ethics Office just as they are for any other Council Member. CM Clark-Murray asked what CM Carrico's goals would be, should he get elected as Vice President. CM Carrico said his number one goal would be to support the Council President and their goals for that year.

CVP Randy White said he agrees with what's been said about CM Carrico thus far and appreciates his leadership style.
