I. Welcome and Introduction

Councilman Mike Gay'welcomed everyone to the notice meeting and began introductions.

Councilman Gay gave an overview of the ci tggo gpvset in place for the George Crady Bridge Fishing Pier. This agreement includes details on matters such as funds and the responsibility for future maintenance. Councilman Gay voiced the concerns regarding the deterioration, which has caused the access on the Duval side of the bridge to be closed off.

KKO Open Discussion

Attendees expressed the importance of this bridge along with voicing their thoughts, questions and suggestions. Councilman Gay echoed the importance and the desperate need to provide the community with an understanding on a solution. Brian Burket with COJ Parks and Recreation Department voiced the first step is to look over the Bridge Assessments to determine if there is a long-term future for the existing bridge.

Members of the public spoke on their needs/concerns on the condition of the bridge and funds.

VI. Closing Remarks

Council members voiced they wish to see immediate relief to the short-term needs such as running water and bait tables. Representative Black voiced that he was not aware the running water had been cut off and that his office will work on a solution. Councilman Gay then thanked all in attendance and encouraged those who have not been to the George Crady Fishing Pier, to walk it and see that we need more of that kind of environment within our city.
