Hi Susie,

As mentioned in our phone conversation a few minutes ago, I am faxing a copy of my warranty deed for my home at 1136 New Berlin Road, Jacksonville, FL.. Also attached is a copy of the actual documentation on file at the city property tax office. You will notice, Daryl Hill Road is NOT the easement RECORDED on my property. I have been advised the City will be correcting the location of Daryl Hill to its proper location whenever "they" complete the four lane issue of New Berlin Rd. I was told by the City that since property was all "family owned" easements were applied to deeds (as is recorded) but family members used easement instead of the actual Daryl Hill Rd for convenience. All mailboxes were placed at my entrance driveway shared by Ms. Evans as it was in front of the old "home place".

For the reason mentioned above, I do not feel comfortable signing an additional easement as demanded by the new owner of property behind me currently using the easement as "Daryl Hill Rd". There are about 6 other property owners that use this easement and they managed to purchase their properties before I bought my home at 1136 New Berlin Rd without needing additional easement. Since I have owned this property this issue came up 3 years ago with another property owner (Ms. Evan's son selling his home) and when I contacted the attorney that conducted the sale of my property - Mr. Bernard, he assured me the easement was properly recorded and there was no need for me to sign another easement of any kind and that I had "Title Insurance" also. The son successfully sold his property without my signing additional easement. This was explained to Mr. Phitides before he purchased the property from Ms. Evans so he realizes he is not in any manner "land locked". He also bought another easement from Ms. Evans to this property on opposite side of said property.

I have enclosed the letter from Attorney Dezern and the form he request (rather strongly) that I sign and send back. Since I have "Title Insurance" I feel this manner could be put to rest by American Title. I do not want to go through this issue whenever any of the other neighbors decide to sell, etc.

I will await you reply and appreciate your assistance.
