ORDERED AND ADJUDGED:

1. As to Count I of the Complaint for Declaratory Relief, NextEra is not entitled to

the declaratory relief sought and shall go hence without day.

2. As to Count II of the Complaint for Injunctive Relief, NextEra is not entitled to the

injunctive relief sought and shall go hence without day.

3. The Initial Gross and Net Proceeds are not exempt from disclosure as public

records.

4. All other relief sought by Plaintiff NextEra is hereby **denied**.

5. The Interim Confidentiality Order, entered March 23, 2020, is hereby **vacated**.

6. Based upon NextEra's acknowledgment to the Court that the trial exhibits do not

contain information exempt from disclosure as public records, all trial exhibits shall be filed in the

public court file in this case.

7. Within fifteen (15) days of NextEra's receipt of the transcript of the trial, counsel

for NextEra shall review the transcript of the trial and redact those portions of the in camera

proceedings that it contends contain trade secrets or proprietary confidential business information.

NextEra shall then immediately file the redacted transcript in the public court file in this action.
