Dear Records Custodian:

Enclosed you will find a subpoena duces tecum issued to your company by the Jacksonville City Council Special Investigatory Committee on JEA Matters (the "SIC") on behalf of the City of Jacksonville (the "City"). You will note that the subpoena requests that you or your designee appear for live testimony at the date and time listed in the attached subpoena, as well as produce records responsive to the enclosed requests. However, please note that you may be excused from appearing in person by producing authenticated copies of the requested documents to me in advance. Under the current circumstances, the SIC would strongly prefer production of responsive documents by electronic means, which may include native format of documents that are not in a proprietary format. The City of Jacksonville agrees to pay 15 cents per page for any necessary physical copies of the documents.

In addition to your obligations under this subpoena, please consider the subpoena a public records request under the Florida Public Records Act, Chapter 119, Florida Statutes. Thus, we are also requesting that you provide us with the opportunity to copy or inspect the requested documents to the extent that you have public records in your firm's possession or control. To the extent that your company is in possession or control of public records, the Public Records Act requires your firm to acknowledge requests promptly and to respond in good faith. If you refuse to produce all, or part, of a document constituting a public record, please state in writing the basis for the denial, including the exact statutory citation authorizing the denial as required by Section 119.07 of the Florida Statutes.

YOU ARE HEREBY COMMANDED to appear before the City Council Special Investigatory Committee on JEA Matters at its meeting on **Monday, May 18, 2020, at 5:00 p.m.**, at 117 West Duval Street, Council Chambers, 1st Floor, City Hall, Jacksonville, Florida, to testify and to speak the truth about, and to have with you at that time and place, for inspection and copying, all documents within your possession, custody or control relating to, the following:

- (1) A list of all lobbyists, attorneys, and consultants employed by you in connection with the JEA ITN**
- (2) Any document showing that you were or were not given an opportunity to physically inspect JEA assets at any time after January 1, 2018**


You may bring copies in lieu of originals and may condition the preparation of copies upon payment in advance of reasonable costs.

You may comply with this subpoena by providing legible copies of the items to be produced on or before the scheduled appearance to: Christopher M. Garrett, Assistant General Counsel, City Hall, St. James Building, 117 W. Duval Street, Suite 480, Jacksonville, FL 32202; phone (904)255-5075. You may condition the preparation of the copies upon payment in advance of the reasonable costs of production. You may mail or deliver the copies to the Assistant General Counsel and thereby eliminate your appearance at the time and place specified above. If you object to the production please give written notice to the Assistant General Counsel in advance of the due date for the production.

This subpoena duces tecum is issued under the authority of Sections 5.09 and 18.01, Charter of the City of Jacksonville, and Chapter 134, Jacksonville Ordinance Code. This subpoena is continuing in nature; if you are not served at least seven (7) days prior to the above

Special Investigatory Committee meeting, you are required to appear at the next Special Investigatory Committee meeting that is more than seven (7) days after service.
