Topics: A final review of the proposed changes to Article 21 of the City's Charter (which established

the JEA, giving it authority to own, manage and operate the City's utilities system) and our first

look at a draft of the legislation which incorporates the changes to Article 21.

Overview

Our last meeting was held on Monday, June 8, 2020. We revisited a couple of the items that had been discussed prior...JEA's procurement process, the deferred compensation and incentive plans, and the possible incorporation of additional ethics language into the Article. Beyond that Ms. Hodges presented an updated **Summary Table of Changes**, highlighting those changes agreed upon at our May 27th meeting. CM Priestly Jackson presented a handout that addressed essentially two items. The first related to transparency (Section 21.03) and the second a clearer delineation of powers afforded to JEA {Sections 21.04 (p) & 21.04 (v)}. In a similar vein the last item taken up, as raised by CM DeFoor, related to the limitation on JEA's ability to "...explore, investigate or consummate a privatization or transfer to an entity by sale, lease or assignment..." A discussion ensued to determine whether or not a referendum (addressing this particular item) would be required. The Office of General Counsel subsequently took up the matter and determined no such referendum would be necessary. As before I would like to thank my colleagues, the OGC staff, the Legislative Services staff and the many stakeholders who contributed their time and resources to this effort.
