Hello,

As a resident of Riverside Avondale, I urge you to ensure that Riverside Avondale is fully included in one Council District. This decision will impact our community's representation in the City for the next 10 years. The committee should reconsider the Maroon II maps and adopt or revise the Maroon IIA map presented as it was compact and kept Murray Hill, Riverside Avondale, Fairfax and Ortega together. Maroon IIB or IIC are also acceptable and all could be tweaked for other considerations like ensuring the Springfield Historic District is entirely within one Council District. These are more than neighborhoods - they are designated zoning/historic overlays recognized by the COJ Planning Department.

The original Maroon, if revised to put Riverside and Avondale back together, should also add Murray Hill and keep us with District 14 with our historic neighbors Fairfax and Ortega.
