And year after year, the creek continues to fill in with sand/silt. But this last storm has **completely clogged** this creek which is a watershed. Not much of a watershed now.

We, along with many of our neighbors, flooded in the Irma storm<u>Our home was surrounded by water on all sides, with no where for the water to go. It is inevitable that flooding is sure to happ again with the creek completely clogged now.</u> We don't feel that we can rightfully plan for hurricane preparedness what can we do if the water can't drain properly?

There are really several issues that we face in addition to more flooding. The manaes and other fish can no longer come into the creek. And, we personally have lost our access to the St Johns River which devalues our property value, as well as the property values of our neighbors.

It is our understanding that several drainage systems from parking lots on San Jose Blvd pour into this creek (Walmart, Emergency Center, Cancer Center, shopping center).
