SUBJECT:

2021 Stormwater Fee Adjustments, Exemptions and Credits Fiscal Year Report

Pursuant to Sec. 754.109(e), the following is a summary of the stormwater fee adjustments, exemptions and credits applied by fiscal year since the start of stormwater fee billing in May 2008. The fees are charged by calendar year, so each fiscal year's total represents parts of two billing years.

The actions are defined as follows:

Adjustments:

Corrections to a property's base billing characteristics, such as residential category, number of

dwellings charged one or both fees, and/or amount of total impervious area.

Exemptions:

Relief from payment of the stormwater fee; described as "user fee reductions" in Sec. 754.109(a). Eligibility requirements: property owners classified by the Internal Revenue Service as a 501(c)(3) organization; or, property owners whose household income is equal to or below 150% of the Federal Poverty Level, as determined by the U.S. Department of Health and Human Services. The

city is required to reimburse the Utility for these exemptions under Sec. 754.110.

Credits:

Discounts offered by the Jacksonville Stormwater Utility to property owners who provide privately-funded stormwater-related facilities and/or services that benefit the city's stormwater management efforts.

This report includes the value of early payment discounts that have been applied to the stormwater fee, as reported by the Tax Collector's Office. The early payment discounts are applicable to non-ad valorem assessments pursuant to Fla. Stat. §197.3632(8)(a).
